## TRADEMARK ASSIGNMENT

THIS TRADEMARK ASSIGNMENT (this "Assignment") is made as of January 15, 2008, by Sirchie Finger Print Laboratories, Inc., a New Jersey corporation ("Assignor"), to and for the benefit of Sirchie Acquisition Company, LLC, a Delaware limited liability company ("Assignee").

### Recitals

A. Assignor and Assignee are parties to that certain Amended and Restated Stock and Asset Purchase Agreement, dated as of September 12, 2007 (the "Purchase Agreement"), by and among Assignor, Assignee, Premier Crown Corporation, a North Carolina corporation, American Institute of Applied Science, Inc., a New York corporation, Hunter Place Associates, a North Carolina general partnership, Forensic Products Inc., a New York corporation, Fingerprint Equipment Laboratories, Inc., an Illinois corporation d/b/a Ace Fingerprint Equipment Labs, each of John Carrington, Kay Carrington, Scott Carrington and Kent Carrington, and John Carrington, in his capacity as the representative of the Stockholders thereunder, pursuant to which Assignee agreed to purchase, and Assignor agreed to sell, transfer, assign, convey and deliver to Assignee, all of Assignor's rights and interests in and to the Purchased Assets (including the Trademarks), free and clear of any and all Liens other than Permitted Liens.

B. This Assignment is being executed and delivered pursuant to Section 3.2(d) of the Purchase Agreement as a condition to the Closing under the Purchase Agreement.

### Agreement

NOW, THEREFORE, in consideration of the foregoing, and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor does hereby agree as follows:

1. Recitals. The recitals set forth above are incorporated herein as part of this Assignment.

2. Defined Terms. All capitalized terms used and not otherwise defined herein shall have the respective meanings set forth in the Purchase Agreement.

3. Assignment. In accordance with the terms of the Purchase Agreement, Assignor hereby sells, transfers, assigns, conveys and delivers to Assignee, its successors and assigns, forever, all of Assignor's legal, beneficial and other right, title and interest and good will in and to all of its United States trademarks, trade names and service marks used in connection with the Business, including, without limitation, all registrations and common law rights in and to the trademarks identified in Exhibit A (collectively, the "Marks"), as well as the right to recover damages and/or profits which have arisen or may arise from any infringement of the same; the rights to such Marks to be exclusively owned by Assignee for its own use, and to inure to the benefit of its successors and assigns.
