#### INTELLECTUAL PROPERTY ASSIGNMENT

  - b. acknowledge that Woodard shall hereafter have no ownership, license rights, right to use, or any other right, title or interest in or to any part of the Intellectual Property.
- 2. Further Assurances. Woodard shall perform such acts as Woodard--CM may reasonably request to vest title to the Intellectual Property in Woodard--CM, including all steps to transfer control of the domain names listed on *Exhibit A* to Woodard--CM. In
