INTELLECTUAL PROPERTY SECURITY AGREEMENT

This INTELLECTUAL PROPERTY SECURITY AGREEMENT (as amended, amended and restated, supplemented or otherwise modified from time to time, the "IP Security Agreement") dated February 20, 2008, is made by W2007 Stratosphere Propco, L.P., W2007 Stratosphere Land Propco, L.P., W2007 Aquarius Propco, L.P., W2007 Arizona Charlie's Propco, L.P., and W2007 Fresca Propco, L.P., each a Delaware limited partnership (collectively, jointly and severally, together with their permitted successors and permitted assigns, "Grantor"), in favor of Fidelity National Title Agency of Nevada, Inc., a Nevada corporation (together with its permitted successors and permitted assigns, the "Trustee"), for the benefit of Goldman Sachs Commercial Mortgage Capital, L.P., a Delaware limited partnership (together with all its successors and assigns, "Beneficiary").

WHEREAS, Grantor has entered into a Loan Agreement dated as of February 20, 2008 (as amended, amended and restated, supplemented or otherwise modified from time to time, the "Loan Agreement"), with Beneficiary. Terms defined in the Loan Agreement and not otherwise defined herein are used herein as defined in the Loan Agreement.

WHEREAS, as a condition precedent to the Beneficiary making the Loan, Grantor has executed and delivered that certain Deed of Trust, Assignment of Rents and Leases, Collateral Assignment of Property Agreements, Security Agreement and Fixture Filing dated February 20, 2008 for the benefit of Trustee and Beneficiary (as amended, amended and restated, supplemented or otherwise modified from time to time, the "Deed of Trust").

WHEREAS, under the terms of the Deed of Trust, the Grantor has granted to the Trustee, for the ratable benefit of the Beneficiary, a security interest in, among other property, the Intellectual Property (as defined in the Deed of Trust), and have agreed to execute this IP Security Agreement for recording with the U.S. Patent and Trademark Office, the United States Copyright Office and other governmental authorities.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Grantor agrees as follows:

SECTION 1. Grant of Security. Grantor hereby grants to the Trustee for the benefit of the Beneficiary a security interest in all of the Intellectual Property (as defined in the Deed of Trust), including, without limitation, the patent and patent applications set forth on Schedule A hereto, the trademark and service mark registrations and applications, including the goodwill of the business connected with the use of, or symbolized by the foregoing, set forth in Schedule B hereto, the copyright registrations and applications set forth in Schedule C hereto and the exclusive licenses relating to the foregoing set forth in Schedule D hereto, if any (the "Collateral"). Notwithstanding anything to the contrary in this Agreement, this Agreement shall not constitute a grant of a security interest in any Collateral to the extent such grant would result in the forfeiture or material impairment of the Grantor's rights in such property including, without limitation, any trademark or service mark applications filed in the United States Patent and Trademark Office on the basis of Grantor's "intent-to-use" such trademark or service mark,

unless and until acceptable evidence of use of such Trademark has been filed with and accepted by the United States Patent and Trademark Office pursuant to Section 1(c) or Section 1(d) of the Lanham Act (15 U.S.C. 1051, et seq.).

SECTION 2. <u>Security for Obligations</u>. The grant of a security interest in the Collateral by Grantor under this IP Security Agreement secures the payment of all Obligations (as defined in the Deed of Trust) of Grantor now or hereafter existing under or in respect of the Loan Documents, whether direct or indirect, absolute or contingent, and whether for principal, reimbursement obligations, interest, premiums, penalties, fees, indemnifications, contract causes of action, costs, expenses or otherwise.

SECTION 3. <u>Recordation</u>. Grantor authorizes and requests that the Register of Copyrights, the Commissioner for Patents and the Commissioner for Trademarks and any other applicable government officer record this IP Security Agreement.

SECTION 4. <u>Execution in Counterparts</u>. This IP Security Agreement may be executed in any number of counterparts, each of which when so executed shall be deemed to be an original and all of which taken together shall constitute one and the same agreement.

SECTION 5. Grants, Rights and Remedies. This IP Security Agreement has been entered into in conjunction with the provisions of the Deed of Trust. Each Grantor does hereby acknowledge and confirm that the grant of the security interest hereunder to, and the rights and remedies of, the Trustee with respect to the Collateral are more fully set forth in the Deed of Trust, the terms and provisions of which are incorporated herein by reference as if fully set forth herein. In the event any provision of this IP Security Agreement conflicts with a provision in the Deed of Trust, the Deed of Trust shall prevail.

SECTION 6. <u>Governing Law</u>. This IP Security Agreement shall be governed by, and construed in accordance with, the laws of the State of New York.

SECTION 7. <u>Severability</u>. If any provision of this IP Security Agreement is invalid or unenforceable, then such provision shall be given full force and effect to the fullest possible extent, and all of the remaining provisions of this IP Security Agreement shall remain in full force and effect and shall be binding on the parties hereto.
