Pursuant to the provisions of Section 263 of the General Corporation Law of the State of Delaware (the "DGCL") and Section 17-211 of the Delaware Revised Uniform Limited Partnership Act (the "DRULPA"), the undersigned hereby submits the following Certificate of Merger for filing and certifies that:

**FIRST:** The names of the parties to the merger (the "Constituent Entities") are FIFTH STREET MEZZANINE PARTNERS III, L.P., a limited partnership formed and existing under the laws of the State of Delaware (the "Partnership"), and FIFTH STREET FINANCE CORP., a corporation incorporated and existing under the laws of the State of Delaware (the "Corporation"). The jurisdiction of domicile, formation or organization of each of the Constituent Entities is the State of Delaware.
