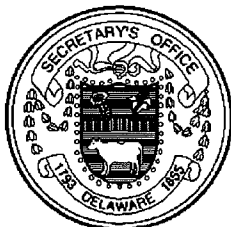

Vanderweil Facility Advisors, Inc., a corporation organized and existing under and by virtue of the General Corporation Law of the State of Delaware, DOES HEREBY CERTIFY:

**FIRST:** That the Board of Directors of said corporation at a duly called meeting adopted resolutions proposing and declaring advisable that the Certificate of Incorporation of said corporation be amended and that such amendment be submitted to the stockholders of the Corporation for their consideration, as follows:

**RESOLVED:** That the Board of Directors of the Corporation recommends and deems it advisable to the Corporation and its stockholders that Article First of the Third Amended and Restated Certificate of Incorporation of the Corporation (the "Charter") be amended (the "Article First Amendment") so that it shall be and read in its entirety:

**FIRST:** The name of the Corporation (the "Corporation") is VFA, Inc.

**RESOLVED:** That the Board of Directors of the Corporation recommends and deems it advisable to the Corporation and its stockholders that Section A.6B of Article Fourth of the Charter be amended (the "Article Fourth Amendment", and together with the Article First Amendment, the "Charter Amendments") by deleting the number "4,152,359" and substituting therefor the number "5,052,359".

**RESOLVED:** That the Charter Amendments and the Plan Increase be submitted to the stockholders of the Corporation for their approval and adoption in compliance with Sections 228 and 242 of the General Corporation Law of the State of Delaware.

**RESOLVED:** That, from and after the approval of the Charter Amendments by the stockholders of the Corporation, the officers of the Corporation be, and they hereby are, and each of them acting singly hereby is, authorized to execute the Charter Amendments, and that the officers of the Corporation be, and they hereby are, and each of them acting singly hereby is, authorized to file the Charter Amendments with the Secretary of State of the State of Delaware in the form and manner approved by the stockholders.

**SECOND:** That in lieu of a meeting and vote of stockholders, the stockholders have given written consent to said amendments in accordance with the provisions of section 228 of the General Corporation Law of the State of Delaware.

**THIRD:** That the aforesaid amendments were duly adopted in accordance with the applicable provisions of sections 228 and 242 of the General Corporation Law of the State of Delaware.
