**RELEASE OF SECURITY INTEREST IN TRADEMARKS**

**THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS** (this "Release") is made as of April 4, 2008 ("Effective Date") by and between D.B. ZWIRN SPECIAL OPPORTUNITIES FUND, L.P., AS Agent, a Delaware limited partnership, with its principal office at 745 Fifth Avenue, 18th Floor, New York, New York 10151 ("Grantee"), and Symon Holdings Corporation, a Delaware corporation, Symon Communications, Inc., a Delaware corporation, and Target Vision, Inc., a Delaware corporation, with offices at 500 North Central Expressway, Suite # 175, Plano, Texas 75074 (collectively, jointly and severally "Grantors" and each individually "Grantor").

**WHEREAS**, pursuant to the terms and conditions of that certain trademark security agreement by and between Grantors and Grantee dated October 19, 2005 (the "Trademark Security Agreement"), Grantors granted to Grantee a continuing security interest in and to all of Grantors' right, title and interest in and to all of the trademarks, and registrations of and applications to register the foregoing, and all of the trade names and assumed names owned by Grantors (collectively, the "Trademark Collateral"), including, without limitation, the United States trademark registrations, the United States applications for trademark registration, the foreign trademark registrations and the foreign applications for trademark registration, the unregistered trademarks and the trade names and assumed names set forth on Schedule A attached hereto, in each case, together with the goodwill associated therewith;

**WHEREAS**, the Trademark Security Agreement was recorded with the United States Patent and Trademark Office ("PTO") on October 27, 2005, at Reel 3183, Frame 0037.

**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Grantee hereby terminates the Trademark Security Agreement, and hereby terminates, cancels and releases any and all security interests it has against the Trademark Collateral, in each case without recourse to Grantee, and without any representation or warranty of any kind, express or implied.

Grantee shall, at Grantors' sole cost and expense, take all reasonable further actions, and provide to Grantors, their successors, assigns or other legal representatives, all such reasonable cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably requested by Grantors (such request to be reasonable in all material respects, including, without limitation, with respect to the form and substance of such additional instruments or writings) and necessary to effectuate the purposes of this Release.
