The undersigned corporation, pursuant to Sections 180.1101 and 180.1105 of the Wisconsin Business Corporation Law, for the purpose of merging Emteq Lighting & Cabin Systems, Inc., a Wisconsin corporation (the "Non-Surviving Corporation"), into Emteq Aerospace, Inc., a Wisconsin corporation and the surviving entity in such merger (the "Surviving Corporation"), hereby executes the following Articles of Merger:

1. The Non-Surviving Corporation is hereby merged (the "Merger") into the Surviving Corporation pursuant to the terms and conditions of a Plan of Merger (the "Plan of Merger") adopted by the Non-Surviving Corporation and the Surviving Corporation.

2. The effective time of the Merger shall be as of 11:59 p.m. Central time on December 31, 2007.

3. The Surviving Corporation is not a direct or indirect wholly-owned subsidiary or parent with respect to the Non-Surviving Corporation.

4. The Plan of Merger has been approved and adopted in accordance with Section 180.1103 of the Wisconsin Business Corporation Law.

5. The Articles of Incorporation of Emteq Aerospace, Inc. will be the Articles of Incorporation of the Surviving Corporation, except that at the Effective Time of the Merger, Article 1 of the Articles of Incorporation of the Surviving Corporation shall be amended to read in its entirety as follows:

Article 1. The name of the corporation is Emteq, Inc.

6. The Plan of Merger is on file at the principal place of business of the Surviving Corporation.

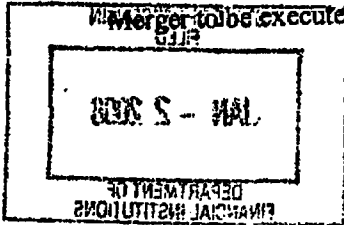

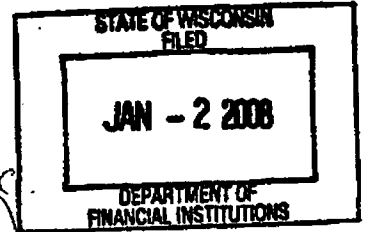
