TRADEMARK SECURITY INTEREST
(SHORT-FORM)

This TRADEMARK SECURITY INTEREST, dated as of _____, among EIDOS INTERACTIVE LIMITED ("Eidos" or "Grantor"), and LLOYDS TSB BANK PLC ("Lloyds"), as Security Agent for the Finance Parties (the "Trademark Security Interest Agreement").

Reference is made to the Deed of Charge of Intellectual Property dated as of 31 January 2008 (as amended, supplemented or otherwise modified from time to time, the "Charge"), among Eidos and Lloyds as Security Agent. The Lenders agreements in respect of extensions of credit to Eidos are set forth in the Facility Agreement dated as of 18 December 2006 (as amended, supplemented or otherwise modified from time to time, the "Agreement"), among Lloyds and Eidos. Eidos will derive substantial benefits from the extension of credit pursuant to the Agreement and is willing to execute and deliver this Trademark Security Interest Agreement in order to induce the Lenders to extend such credit. Accordingly, the parties hereto agree as follows:

Section 1. Terms. Capitalized terms used in this Trademark Security Interest Agreement and not otherwise defined herein have the meanings specified in the Charge. The rules of construction specified in Section 1 of the Charge also apply to this Agreement.

Section 2. Grant of Security Interest. As security for the payment or performance, as the case may be, in full of the obligations, Grantor, pursuant to and in accordance with the Charge, did and hereby does grant to the Security Agent, its successors and assigns, for the benefit of the Finance Parties, a security interest in, all right, title and interest in or to any and all of the following assets and properties now owned or at any time hereafter acquired by Grantor or in which Grantor now has or at any time in the future may acquire any right, title or interest (collectively, the "Trademark Collateral"):

(a) all trademarks, service marks, trade names, corporate names, trade dress, logos, designs, fictitious business names, other source or business identifiers, now existing or hereafter adopted or acquired, all registrations and recordings thereof, and all registration and recording applications filed in connection therewith, including registrations and registration applications in the USPTO, and all extensions or renewals thereof, as well as any unregistered trademarks and service marks used by Grantor, and (b) all goodwill connected with the use of and symbolized by such marks; *provided that*, the grant of security interest shall not include any trademark, service mark or other application for registration that may be deemed invalidated, canceled or abandoned due to the grant and/or enforcement of such security interest unless and until such time that the grant and/or enforcement of the security interest will not affect the validity of such trademark, service mark or other application for registration.

Section 3. Termination. This Trademark Security Interest Agreement is made to secure the satisfactory performance and payment of the obligations. This Trademark Security Interest Agreement and the security interest granted hereby shall terminate with respect to all of Grantor's obligations and any lien arising therefrom shall be automatically released upon termination of the Charge or release of Grantor's obligations thereunder. The Security Agent shall, in connection with any termination or release herein or under the Charge, execute and deliver to Grantor as such Grantor may request, an instrument in writing releasing the security interest in the Trademark Collateral acquired under

this Agreement. Additionally, upon such satisfactory performance or payment, the Security Agent shall reasonably cooperate with any efforts made by Grantor to make of record or otherwise confirm such satisfaction including, but not limited to, the release and/or termination of this Trademark Security Interest Agreement and any security interest in, to or under the Trademark Collateral.

Section 4. Supplement to the Charge. The security interests granted to the Security Agent herein are granted in furtherance, and not in limitation of, the security interests granted to the Security Agent pursuant to the Charge. Each Grantor hereby acknowledges and affirms that the rights and remedies of the Security Agent with respect to the Trademark Collateral are more fully set forth in the Charge, the terms and provisions of which are hereby incorporated herein by reference as if fully set forth herein. In the event of any conflict between the terms of this Trademark Security Interest Agreement and the Charge, the terms of the Charge shall govern.

Section 5. Representations and Warranties. Grantor represents that a true and correct list of all of the existing material Trademark Collateral consisting of U.S. Trademark registrations or applications owned by the Grantor, in whole or in part, is set forth in Schedule I.


