**Petition for Correction of Mistake Under §7(h) of the Trademark Act**

Under §7(h) of the Trademark Act, the owner of the above-referenced registrations respectfully requests correction of a mistake in the above-referenced registrations. As illustrated by the attached declaration, the mistake was made in good faith through the fault of the owner.

The purpose of the correction is to cure an inadvertent error in the manner in which the owner's name is set forth in the registrations. It is not to substitute another entity as the owner.




1. My name is Richard Roy and I make the following statements under penalty of perjury.


