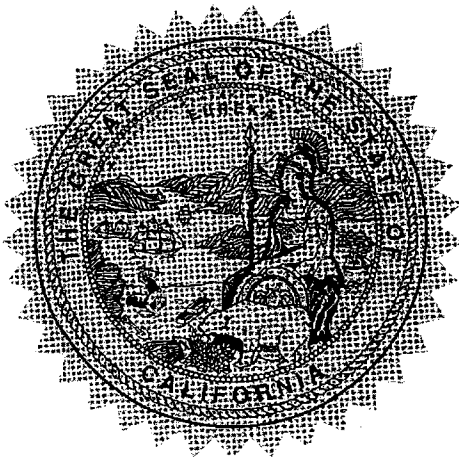

1. They are the President and Assistant Secretary, respectively, of Polar Vision, Inc., ( the "Corporation") a California corporation.
2. Article I of the Amended and Restated Articles of Incorporation of the Corporation has been amended to read as follows:

"ARTICLE I

The name of the Corporation is DuPont Display Solutions, Inc."

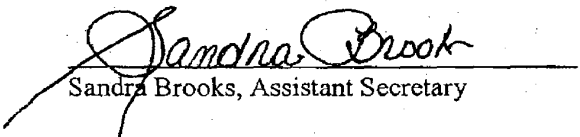
3. The foregoing amendment of the Amended and Restated Articles of Incorporation has been duly approved by the Board of Directors of the Corporation.

4. The foregoing amendment of the Amended and Restated Articles of Incorporation has been duly approved by the required vote of the shareholders of the Corporation in accordance with Section 902 of the California Corporations Code. The total number of outstanding shares of the Corporation is one million (1,000,000) shares of Common Stock, eighty thousand (80,000) shares of Series A Preferred Shares, and two hundred fifty thousand (250,000) shares of Series B Preferred Shares. The number of shares voting in favor of the amendment equaled or exceeded the vote required. The percentage vote required was more than 50% of the out standing shares of each class.
