2. Article I. of the Amended and Restated Articles of Incorporation of this corporation is amended to read as follows:

The name of the corporation is DuPont Display Enhancements, Inc.

3. The foregoing amendment of the Articles of Incorporation has been duly approved by the board of directors.
4. The foregoing amendment of the Articles of Incorporation has been duly approved by the required vote of shareholders in accordance with Section 9, California Corporations Code. The total number of outstanding shares of the corporation is 1,000,000 shares of Common Stock, 80,000 shares of Series A Preferred Shares and 250,000 Shares of Series B Preferred Shares. The number of shares voting in favor of the amendment equaled or exceeded the vote required. The percentage vote required was more than 50% of each class.
