OF TRADEMARK AND  
OTHER INTELLECTUAL PROPERTY SECURITY INTEREST

WHEREAS, RM ACQUISITION, LLC, a Delaware limited liability company (“RM Acquisition”), having its principal office at 8255 N. Central Park, Skokie, Illinois 60076, is the owner of certain United States and foreign trademarks and trademark registrations and applications for trademarks and trademark registrations, and all renewals and extensions thereof, including, without limitation, those set forth in Schedule A attached hereto (the “Trademarks”);

WHEREAS, RM Acquisition has acquired from Rand McNally & Company, a Delaware corporation (“Rand McNally”), the trademarks and trademark registrations and applications for trademarks and trademark registrations set forth in Schedule A attached hereto together with certain other assets of Rand McNally (the “Acquisition”) pursuant to the Asset Purchase Agreement, dated as of December 6, 2007, among RM Acquisition, Rand McNally and John C. Wheeler, as Lenders’ Representative;

WHEREAS, The Bank of Nova Scotia (“Nova Scotia”), having an office at One Liberty Plaza, New York, New York 10006, in its capacity as administrative agent for each lender party to the Second Amended and Restated Credit Agreement, dated as of November 12, 2004, as amended (the “Credit Agreement”), among Rand McNally, as borrower, the financial institutions party thereto (the “Lenders”) and Nova Scotia, as agent for the Lenders (in such capacity, the “Agent”; the Agent and the Lenders are herein referred to as the “Secured Parties”), was granted a security interest for itself and the ratable benefit of the Secured Parties in the Trademarks and all products and proceeds of the Trademarks (the “Collateral”);

WHEREAS, in connection with the Acquisition, the Secured Parties terminated and released all of their interests in the Collateral, and now the Secured Parties desire to terminate and release of record their security interests in the Collateral as specifically set forth in Schedule A hereto; and

NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, the Agent, on behalf of itself and the Secured Parties (without representation, warranty or recourse of any kind or nature), terminates and releases of record its security interest in the Collateral.

The Agent on behalf of the Secured Parties hereby requests the filing and recordation of this Termination and Release together with the annexed Schedule A.
