TIFFANY (NJ) Inc., a New Jersey corporation ("TIFFANY INC."), and TIFFANY (NJ) LLC, a Delaware limited liability company ("TIFFANY LLC"), in order to accomplish the merger of TIFFANY INC. with and into TIFFANY LLC pursuant to Section 14A:10-4.1 *et seq.* of the New Jersey Business Corporation Act (the "NJBCA") and Section 18-209 of the Delaware Limited Liability Company Act (the "DLLCA"), hereby certify that:

**FIRST:** The name of the surviving limited liability company is TIFFANY (NJ) LLC, a Delaware limited liability company.

**SECOND:** The name of the New Jersey corporation being merged into this surviving limited liability company is TIFFANY (NJ) INC. 0100788318

**THIRD:** Annexed hereto as Exhibit A and made a part hereof is the Agreement and Plan of Merger, dated January 29, 2008 (the "Merger Agreement"), which has been approved by all the directors and the sole shareholder of TIFFANY INC. and all of the managers and sole member of TIFFANY LLC, all in accordance with 14A:10-4.1 *et seq.* of the NJBCA and Section 18-209 of the DLLCA and executed by both TIFFANY INC and TIFFANY LLC, in each case by unanimous written consent dated January 29, 2008.

**FOURTH:** This Merger is to be effective as of 12:00 a.m., on February 1, 2008.

**FIFTH:** There is one class of shares entitled to vote on the Merger Agreement. There are 1,000 shares of Stock of TIFFANY INC. entitled to vote on the Merger Agreement. All of the stockholders of TIFFANY INC. entitled to vote on the Merger Agreement have voted in favor of the merger pursuant to a unanimous written consent of the stockholders dated January 29, 2008.

**SIXTH:** TIFFANY LLC agrees that it may be served with process in the State of New Jersey in any action, suit or proceeding for enforcement of any obligation of TIFFANY INC., as well as in any suit or other proceeding to enforce the rights of a dissenting shareholder
