**ASSIGNMENT OF TRADEMARKS**  
(NUNC PRO TUNC)

This assignment of trademarks ("Assignment"), dated as March 26, 2008, is made by and between PDLP of Lorain, Inc. (formerly known as Flexon, Inc.), a Pennsylvania corporation ("PDLP"), and Hormann Flexon, LLC (formerly known as TMCH Acquisition, LLC), a Delaware corporation ("HFL").

WHEREAS, PDLP and HFL are parties to a previously executed asset purchase agreement dated September 24, 2007 in which, *inter alia*, PDLP agreed to sell to HFL substantially all of the assets used by PDLP to conduct its business;

WHEREAS, PDLP used and is using the Marks which are the subject of issued trademark registrations, as set forth on Schedule A to this Assignment (hereafter the "Marks");

WHEREAS, PDLP desires to assign to HFL all of PDLP's right, title, and interest in and to the Marks, the goodwill of the business symbolized by the Marks, any all common law rights symbolized by the Marks;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, PDLP hereby sells, assigns and transfers to HFL, effective September 24, 2007, the entire right, title, and interest in, to and under the Marks, including any common law rights, and the registrations for the Marks, which are listed above, together with the goodwill of the business connected with the use of and symbolized by the Trademarks and the right to sue for past, present and future infringement thereof;


PDLP further hereby authorizes and requests the Commissioner of Patents and Trademarks of the United States Patent and Trademark Office and the equivalent authority in other respective countries to issue any registrations of such Marks to HFL, for its sole use and behoof, and for the use and behoof of its legal representatives, as fully and entirely as the same would have been held by PDLP had this assignment and sale not been made; and

PDLP further hereby binds itself, its legal representatives, its administrators and its assigns properly to execute such necessary and lawful papers and assignments or other papers and instruments that may be necessary to carry into full force and effect the sale, assignment, transfer and conveyance hereby made or intended to be made and, without obligation to remunerate any associated government or other third party fees, generally do everything possible to aid HFL, its legal representatives and assigns, to obtain and enforce proper protection for the Marks in all countries throughout the World.



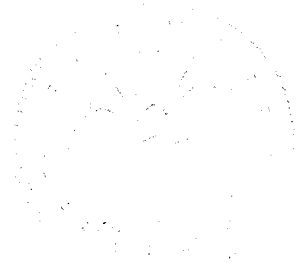
