THIRD PRIORITY TRADEMARK SECURITY AGREEMENT

This THIRD PRIORITY TRADEMARK SECURITY AGREEMENT (this "Agreement") dated as of June 6, 2008, is among RESIDENTIAL CAPITAL, LLC, a Delaware limited liability company (the "Company"), RESIDENTIAL FUNDING COMPANY, LLC, a Delaware limited liability company, GMAC MORTGAGE, LLC, a Delaware limited liability company, HOMECOMINGS FINANCIAL, LLC, a Delaware limited liability company, GMAC-RFC HOLDING COMPANY, LLC, a Delaware limited liability company, and GMAC RESIDENTIAL HOLDING COMPANY, LLC, a Delaware limited liability company (each of the foregoing parties other than the Company, herein a "Guarantor" and collectively, the "Guarantors"), and each other Person that agrees to become a "Grantor" by executing and delivering a Joinder Agreement pursuant to Section 15 (each of the Company, each Guarantor and each such other Person is herein a "Grantor" and collectively, the "Grantors"); U.S. BANK NATIONAL ASSOCIATION, as trustee on behalf of the Holders (together with its successor(s) or assigns thereto in such capacity, the "Trustee"); and Wells Fargo Bank, N.A., as third priority collateral agent (together with its successor(s) or assigns thereto in such capacity, the "Third Priority Collateral Agent") for the Notes Parties (terms used in the preamble and recitals have the definitions incorporated by reference in Section 1).

WITNESSETH:

WHEREAS, the Company is issuing the Notes pursuant to the Indenture, dated as of the date hereof, among the Company, the Guarantors and U.S. Bank National Association, as trustee, (as amended, supplemented, restated or otherwise modified from time to time, the "Indenture");

WHEREAS, the Guarantors have pursuant to Article X of the Indenture, among other things, unconditionally guaranteed the obligations of the Company under the Indenture (each such guarantee so made by a Guarantor, herein its "Guaranty");

WHEREAS, the obligations of the Company under the Indenture and the obligations of each of the Guarantors under the Guaranties are secured pursuant to the Third Priority Pledge and Security Agreement and Irrevocable Proxy, dated as of the date hereof (as amended, supplemented, restated or otherwise modified from time to time, the "Third Priority Security Agreement");

WHEREAS, each Grantor has duly authorized the execution, delivery and performance of this Agreement; and

WHEREAS, pursuant to Section 8.01 of the Indenture, each Grantor has executed and delivered this Agreement;

WHEREAS, it is in the best interests of each Grantor to execute this Agreement inasmuch as each Grantor will derive substantial direct and indirect benefits from the issuance of the Notes.

NOW, THEREFORE, for and in consideration of the foregoing premises and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties hereto agree as follows:

Section 1. Definitions. Unless otherwise defined herein or the context otherwise requires, terms used in this Agreement, including its preamble and recitals, have the meanings provided in the Third Priority Security Agreement.

Section 2. Grant of Security Interest. As security for the prompt payment in full in cash and performance of all Obligations, each Grantor hereby pledges to the Third Priority Collateral Agent for the benefit of the Notes Parties, and grants a continuing security interest to the Third Priority Collateral Agent for the benefit of the Notes Parties in all of the following property, whether now or hereafter existing or acquired by such Grantor (the "Trademark Collateral");

(a) (i) all of its trademarks, service marks, business names, trade names, designs, logos, and/or other source and/or business identities and the goodwill of the business relating thereto, and all registrations or applications for registrations which have heretofore been or may hereafter be issued thereon throughout the world, including those referred to in Schedule I hereto (collectively referred to as the "Trademark Collateral");

(b) all trademark licenses for the grant by or to the Grantor of any right to use any Trademark Collateral; and

(c) all Proceeds of the foregoing, including (to the extent not covered in the defined term "Proceeds") any claim by the Grantor against third parties for past, present or future infringement or dilution of any Trademark Collateral, or any registration or license related to the Trademark Collateral, or for any injury to the goodwill associated with the use of any Trademark Collateral or for breach or enforcement of any license related to any Trademark Collateral and all rights corresponding thereto throughout the world;

provided that, notwithstanding the foregoing, "Trademark Collateral" shall not include (i) any asset, including any account, note, contract, lease, financing arrangement, general intangible, equity investment, interests in joint ventures or other agreement to the extent that the grant of a security interest therein would violate applicable Requirements of Law, result in the invalidation thereof or provide any party thereto with a right of termination with respect thereto (in each case, after giving effect to applicable provisions of the UCC and other applicable Requirements of Law and principles of equity) or (ii) any trademark applications filed in the United States Patent and Trademark Office on the basis of such Grantor's "intent-to-use" such trademark, unless and until acceptable evidence of use of the trademark has been filed with the United States Patent and Trademark Office pursuant to Section 1(c) or 1(d) of the Lanham Act (15 USC 1051, et seq.) to the extent that granting a lien in such trademark application prior to such filing would adversely affect the enforceability or validity of such trademark application.

Section 3. Third Priority Security Agreement. This Agreement has been executed and delivered by each Grantor for the purpose of registering the security interest of the Third Priority Collateral Agent in the Trademark Collateral with the United States Patent and Trademark Office and corresponding offices in other countries of the world. The security interest granted hereby has been granted as a supplement to, and not in limitation of, the security interest granted to the Third Priority Collateral Agent for the benefit of the Notes Parties under the Third Priority Security Agreement. The Third Priority Security Agreement (and all rights and remedies of the Third Priority Collateral Agent and the Notes Parties thereunder) shall remain in full force and effect in

accordance with its terms. In the event of irreconcilable differences between this Agreement and the Third Priority Security Agreement, the Third Priority Security Agreement shall control.

Section 4. Release of Liens. The security interests granted herein shall automatically terminate and release:

(a) in accordance with Article VIII of the Indenture; and

(b) upon the earlier of (a) all Obligations having been paid in full in cash, (b) the discharge of the Indenture pursuant to Article XI thereof has occurred or (c) the satisfaction of the conditions in Article XIII of the Indenture with respect to a Legal Defeasance or Covenant Defeasance of the Notes have been satisfied. Upon any such termination, the Third Priority Collateral Agent will, at the Grantors' sole expense, deliver to the Grantors, without any representations, warranties or recourse of any kind whatsoever, all Trademark Collateral held by the Third Priority Collateral Agent hereunder, and execute and deliver to the Grantors such documents as the Grantors shall reasonably request to evidence such termination.

Section 5. Acknowledgment. Each Grantor does hereby further acknowledge and affirm that the rights and remedies of the Third Priority Collateral Agent with respect to the security interest in the Trademark Collateral granted hereby are more fully set forth in the Third Priority Security Agreement, the terms and provisions of which (including the remedies provided for therein) are incorporated by reference herein as if fully set forth herein.

Section 6. Security Document. This Agreement is a Security Document executed pursuant to the Indenture and shall (unless otherwise expressly indicated herein) be construed, administered and applied in accordance with the terms and provisions thereof.


Section 7. Counterparts. This Agreement may be executed by the parties hereto in several counterparts, each of which shall be deemed to be an original and all of which shall constitute together but one and the same agreement.

Section 8. Governing Law. THIS AGREEMENT SHALL BE GOVERNED BY AND CONSTRUED IN ACCORDANCE WITH THE LAWS OF THE STATE OF NEW YORK WITHOUT REGARD TO CONFLICTS OF LAWS PRINCIPLES (BUT WITH REFERENCE TO SECTION 5-1401 OF THE NEW YORK GENERAL OBLIGATIONS LAW, WHICH BY ITS TERMS APPLIES TO THIS AGREEMENT).
