INTELLECTUAL PROPERTY ASSIGNMENT

This INTELLECTUAL PROPERTY ASSIGNMENT (the "Agreement") is effective as of November 30, 2007 (the "Effective Date"), by and between Woods Industries, Inc., a Delaware corporation ("Assignor") Coleman Cable, Inc., a Delaware corporation ("Assignee").

WHEREAS, Assignor is a party to that certain Purchase Agreement dated as of November 1, 2007 (the "Purchase Agreement") whereby the Assignor has agreed to sell, and Assignee has agreed to purchase, substantially all the assets used in connection with the US Business;

WHEREAS, pursuant to the Purchase Agreement, Assignor agrees to assign, transfer and convey all of Assignor's right, title and interest in and to the Intellectual Property to the Assignee; and

WHEREAS, capitalized terms not otherwise defined herein shall have the respective meanings provided in the Purchase Agreement.

NOW, THEREFORE, in consideration of the above premises and of the mutual agreements, provisions and covenants contained in this Agreement and the Purchase Agreement and intending to be legally bound hereby, Assignor and Assignee hereby agree as follows:

1. Assignor hereby assigns, transfers, grants, conveys and delivers to Assignee, its successors, assigns or other legal representatives, all of its right, title and interest in and to the Intellectual Property including the Intellectual Property listed in Schedule A hereto. With respect to Intellectual Property comprising trademarks and service marks, said assignment, transfer, grant, conveyance and delivery to Assignee is together with the goodwill of the business associated with and symbolized by the trademarks and service marks.

2. Assignee is to hold all right, title and interest in and to the Intellectual Property as fully and exclusively as it would have been held and enjoyed by Assignor had the assignment in Section 1 not been made. Assignor shall not contest Assignee's ownership of the Intellectual Property, including in any claim, action, arbitration, suit, inquiry or proceeding.

3. Assignor hereby authorizes Assignee to request the relevant government entity or agency to record Assignee as the assignee and owner of the entire right, title and interest in and to each of the Intellectual Property, for the sole use and enjoyment of Assignee, its successors, assigns and other legal representatives. Assignor agrees that it shall complete and submit the relevant documentation and paperwork with the appropriate domain name registrar, and authorize Assignee to do the same on its behalf, in order to effectuate this assignment with respect to its domain names.

4. This Agreement may be executed in one or more counterparts, and by the different parties hereto in separate counterparts, each of which when executed shall be deemed to be an original but all of which taken together shall constitute one and the same agreement.

5. This Agreement shall be governed by and construed in accordance with the laws of the State of Illinois (without regard to the principles of conflicts of laws thereof).

IN WITNESS WHEREOF, the parties hereto execute this Agreement as of the date first above written.


