#### FIRST AMENDMENT TO TRADEMARK SECURITY AGREEMENT

- (b) The Trademark Security Agreement is amended by adding to <u>Schedule I</u> thereto the Trademarks referred to on <u>Schedule I</u> hereto.
- 3. <u>ACKNOWLEDGMENTS</u>. Grantor acknowledges and agrees that the Trademarks referred to on <u>Schedule I</u> hereto constitute Trademark Collateral; and, for the avoidance of any doubt, to secure the payment and performance of all Obligations, Grantor grants to Lender a security interest in such Trademarks and all proceeds thereof.
