ASSIGNMENT OF PPY TRADEMARKS AND DOMESTIC AGREEMENTS

WHEREAS, on August 25, 1988, an agreement known as the Peter Paul/York Domestic Trademark and Technology License Agreement was entered into between CBI Holdings, Inc. (known at that time as Cadbury Schweppes Inc.) as licensor under such agreement, and Hershey Foods Corporation ("Hershey"), as licensee under such agreement (as amended to date, the "PPY Domestic Agreement");

WHEREAS, CBI Holdings, Inc. transferred ownership of the trademarks licensed under the PPY Domestic Agreement and assigned its rights and obligations as licensor under the PPY Domestic Agreement to Cadbury Beverages Delaware, Inc. of 900 King Street, Rye Brook, NY10573-1238, USA ("CBDI");

WHEREAS, Hershey assigned its rights and obligations under the PPY Domestic Agreement to Homestead, Inc. ("Homestead");

WHEREAS, in connection with the aforesaid assignment, Homestead sublicensed to Hershey its rights and certain of its responsibilities under the PPY Domestic Agreement pursuant to a sublicense of the PPY Domestic Agreement (the "PPY Domestic Sublicense Agreement");

WHEREAS, Homestead was subsequently merged with and into Hershey Chocolate & Confectionery Corporation ("HCCC");

WHEREAS, the PPY Domestic Sublicense Agreement was subsequently amended and restated, effective as of January 1, 1999, to, among other things, add CBDI as a party thereto so as to place CBDI in direct privity with Hershey and HCCC with respect to the PPY Domestic Sublicense Agreement;

WHEREAS, CBDI desires to transfer to Cadbury Ireland Limited of Malahide Road, Coolock, Dublin 5, Ireland its ownership interests in the trademarks set forth on Exhibit A hereto (the "Marks") and related rights licensed by CBDI to HCCC pursuant to the PPY Domestic Agreement and sublicensed by HCCC to Hershey pursuant to the PPY Domestic Sublicense Agreement, as the result of a proposed separation of the Cadbury Schweppes plc's ("CS") North American beverages business from the remainder of the CS business, which will include the separation of CBDI, and Cadbury Ireland Limited desires to accept such assignment; and

WHEREAS, CBDI desires, in connection with the transfer of ownership of the Marks and related rights, to assign to Cadbury Ireland Limited its rights and responsibilities under each of the PPY Domestic Agreement and the PPY Domestic Sublicense Agreement, and Cadbury Ireland Limited desires to accept such assignment and to assume the duties and obligations of CBDI under each of such agreements.

NOW, THEREFORE, for good and valuable consideration:

1. CBDI does hereby assign unto Cadbury Ireland Limited all of CBDI's right, title and interest in, to and under the Marks together with the goodwill associated with the Marks, including, without limitation, any of CBDI's right, title and interest under common law. All rights and privileges, including, without limitation, the right to sue for and receive damages from

the past infringements of the Marks, shall be held and enjoyed by Cadbury Ireland Limited and its successors and assigns.

- 2. CBDI does hereby assign unto Cadbury Ireland Limited all of CBDI's rights and responsibilities under each of the PPY Domestic Agreement and the PPY Domestic Sublicense Agreement. Cadbury Ireland Limited hereby accepts the assignment of each of the PPY Domestic Agreement and the PPY Domestic Sublicense Agreement and undertakes to perform the duties and obligations of CBDI under each of such agreements.
- 3. As consideration for the assignments set forth in Section 1 and 2 above, Cadbury Ireland Limited shall pay to CBDI
- 4. CBDI does hereby agree to execute and deliver at any future date any additional documents as may be reasonably necessary to transfer and assign to and vest in Cadbury Ireland Limited ownership of and good title to the Marks and all other rights transferred hereunder.
- 5. CBDI does hereby authorize and request the Commissioner of Patents and Trademarks of the United States, and any other official throughout the world whose duty is to register and record ownership in trademark registrations and applications for registration of trademarks, to record Cadbury Ireland Limited as the assignee and owner of any and all of CBDI's rights in the Marks.
- 6. This Agreement shall be governed by and construed and enforced in accordance with the laws of the State of New York, United States of America, without giving effect to the conflicts of law principles thereof, and the parties hereto submit to the exclusive jurisdiction of the federal and state courts located in New York, New York in relation to all matters arising out of this Agreement.
