INTELLECTUAL PROPERTY SECURITY AGREEMENT ASSIGNMENT

THIS INTELLECTUAL PROPERTY SECURITY AGREEMENT ASSIGNMENT is made as of June 24, 2008 by Compass Group Diversified Holdings LLC, a Delaware limited liability company, ("Compass") in favor of Bühler Holding AG, a Swiss corporation ("Bühler Holding"). Unless otherwise defined herein or the context otherwise requires, capitalized terms used herein have the meanings given them in the Intellectual Property and Security Agreement between Aeroglide Corporation, a North Carolina corporation ("Aeroglide"), as Grantor, and Compass, as Secured Party, dated as of February 28, 2007 (as amended from time to time, the "Security Agreement").

Recitals

A. Compass, as Lender, entered into that certain Credit Agreement dated as of February 28, 2007 with Aeroglide, as Borrower, and Aeroglide Holdings, Inc, a Delaware corporation ("Holdings"), as Co-Borrower (as amended from time to time, the "Credit Agreement").

B. Pursuant to the Credit Agreement, Holdings, Aeroglide, and the Subsidiaries of Aeroglide, as Grantors, and Compass, as Lender, entered into that certain Guarantee and Collateral Agreement dated as of February 28, 2007 (as amended from time to time, the "Collateral Agreement").

C. Pursuant to the Collateral Agreement, Aeroglide, as Grantor, and Compass, as Secured Party, entered into the Security Agreement, whereby Aeroglide granted Compass a security interest in its Trademarks and Patents, as defined in the Collateral Agreement (the "Intellectual Property Collateral").

D. Compass and Aeroglide recorded the Security Agreement in the Assignment Division of the United States Patent and Trademark Office on March 16, 2007 at Reel 3502, Frame 0297 (trademarks) and Reel 19019, Frame 0830 (patents).

E. As of June 24, 2008, Bühler Holding acquired all right, title and interest of Compass under the Credit Agreement and the other Loan Documents referred to therein (the "Debt Acquisition").


Agreement


