TRADEMARK ASSIGNMENT

This Trademark Assignment (the "Agreement") is entered into as of the 27th day of April, 2004 (the "Effective Date"), by and between Eldredge Lender Services, Inc., an Indiana corporation having an address at 1030 E. 169th Street, Westfield, Indiana 46074 ("Eldredge"), and Allied Solutions, L.L.C., an Indiana limited liability company having an address at 11550 North Meridian Street, Suite 275, Carmel, Indiana 46032 ("Allied Solutions").

WITNESSETH

WHEREAS, Eldredge is the owner of the trademark registrations and pending trademark application listed on attached Exhibit A (the "Trademarks");

WHEREAS, Allied Solutions is desirous of acquiring the Trademarks and Eldredge is willing to assign them to Allied Solutions pursuant to the terms of this Agreement.

NOW, THEREFORE, in consideration of the covenants contained herein and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties agree as follow:

- 1. **Assignment.** Eldredge hereby assigns, transfers and conveys to Allied Solutions all of Eldredge's right, title and interest in and to the Trademarks, in the United States and elsewhere, including the right to sue for past infringement, together with the goodwill of the business symbolized by the Trademarks.
- 2. **Transfer of Files.** Upon Allied Solutions' request, Eldredge shall cause its attorneys to deliver to Allied Solutions all of such attorneys' files concerning the registration and enforcement of the Trademarks.
- 3. **Further Assurances.** The parties agree to take such further actions and execute and deliver such other documents, assignments, certificates, agreements and other instruments as may be necessary to consummate or implement this Agreement.
- 4. **Binding Effect.** This Agreement, and all the terms and provisions hereof, shall be binding upon and shall inure to the benefit of the parties, and their respective successors and assigns.
