

Certificate of Amendment of the Certificate of Incorporation

of

EMBLEMHEALTH, INC.

Under Section 803 of the Not-for-Profit Corporation Law

It is hereby certified that:

FIRST: The name of the corporation is EmblemHealth, Inc. The name under which the corporation was formed was HIP Foundation, Inc.

SECOND: The certificate of incorporation of the corporation was filed by the Department of State on November 21, 1995 under the Not-for-Profit Corporation Law.

THIRD: The corporation is a corporation as defined in subparagraph (a)(5) of Section 102 of the Not-for-Profit Corporation Law and is a Type B corporation under Section 201 of the Not-for-Profit Corporation Law. After the amendment set forth below, which changes the purposes of the corporation, the corporation will remain a type B corporation.

FOURTH: The amendment of the certificate of incorporation of the corporation effected by this certificate of amendment is to change the purposes of the corporation. To accomplish the foregoing smendment, Article Fourth of the certificate of incorporation of the corporation, relating to the purposes of the corporation, is hereby smended to read as follows:

"FOURTH: The corporation is organized and at all times hereafter shall be operated (a) for the benefit of Health Insurance Plan of Greater New York, Inc. ("HIP-NY"), which is qualified as exempt from Federal income tax under Section 501(c)(4) of the Internal Revenue Code of 1986, as amended (the "Code"), as required by and in a manner that satisfies Section 50%(a)(3) of the Code and the Treasury Regulations promulgated thereunder, by promoting, supporting and furthering the educational, scientific, and charitable purposes (within the meaning of Section 170(c)(2) of the Code) of such entity, and (b) to take such other actions as are in furtherance of the purposes stated in clause (a) hereof, including but not limited to, (i) being a member of, and holding a direct or indirect interest in, Group Health Incorporated ("CHIF") or any other not-for-profit corporations and their affiliates, or (ii) taking any other action with respect to, or engage in any other activity with, GHI or such other not-for-profit corporations and their affiliates that does not cause the corporation to violate Section 509(a)(3) of the Code such as engaging in activities in exchange for adequate compensation or providing loans to such organizations on an arms-length basis. If HIP-NY no longer qualifies as an organization deemed to be described in Section 509 (a)(2) of the Code for purposes of Section 509(a)(3) of the Code or is no longer in existence, then the corporation shall operate in furtherance of the educational, acientific, and charitable purposes of one or more other organizations in the healthcare industry that are described in either Section 509(a)(1) or Section 509(a)(2) of the Code. Nothing herein shall authorize the corporation, directly or indirectly, to engage in or include among its purposes any of the activities mentioned in Sections 404(b)

through (w) of the Not-for-Profit Corporation Law without the consents required by Sections 404(b) through (w).

The corporation is empowered:

To take and hold any bequest, devise, gift, purchase, lease or otherwise, any property real or personal, without limitation as to value, mediar as the same may be held by a corporation organized under the Not-for-Profit Corporation Law;

To hold, maintain, use, convey, sell or dispose of such property and to invest, reinvest, administer, collect and receive the income and profits thereof, and expend the principal thereof and income therefrom in any manner as may be permitted by law and as, in the judgment of the Board of Directors, will best promote the purposes for which the corporation is organized;

To have in furtherance of these purposes, all of the powers conferred upon or permitted to corporations organized under the Not-for-Profit Corporation Law; and

To do any and all lawful acts and things which may be necessary, useful, suitable or proper for the furtherance, accomplishment or attainment of any or all of the purposes of the corporation."

FIFTH: The foregoing amendment of the certificate of incorporation of the corporation was authorized by the unanimous consent of the Board of Directors of the corporation at a meeting held on March 21, 2007. There are no seabars entitled to vote on this arendment.

SIXTH: The Secretary of State is designated as the agent of the corporation upon whom process against the corporation may be served. The post office address within the State of New York to which the Secretary of State shall mail a copy of any process against the corporation served upon him is:
