## RELEASE OF TRADEMARK SECURITY INTEREST

This Release of Trademark Security Interest (this "Release") is made effective as of August 15, 2008, by U.S. Bank National Association (as successor trustee to Firststar Bank, N.A.) ("Trustee") in favor of Progressive Gaming International Corporation (formerly known as Mikohn Gaming Corporation) ("PGIC") and its subsidiaries that are guarantors to the Indenture as defined below, collectively with PGIC, "Company").

### Recital

WHEREAS the Company entered into the Collateral Agreement (as defined in that Indenture, dated as of August 22, 2001, among PGIC, its subsidiaries that are guarantors thereto, and Trustee (the "Indenture") in favor of Trustee, pursuant to which Company granted to Trustee, in part, a continuing security interest in all of the Company's right, title and interest in, to and under the trademarks and trademark applications listed on the attached **Exhibit A**, to secure the payment, performance and observance of the obligations referred to in the Collateral Agreement;

WHEREAS the Trustee's security interest was recorded at the United States Patent and Trademark Office ("USPTO") with respect to the domestic federal trademarks and trademark applications listed on **Exhibit A** on January 24, 2002, at Reel Number 2430 and Frame Number 0779;

### Agreement

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, Trustee hereby:

1. releases and reassigns to Company any and all liens, security interests, right, title and interest of Trustee pursuant to the Collateral Agreement in the trademarks more fully described on **Exhibit A**, without recourse or representation or warranty, express or implied; and
2. authorizes and requests the Commissioner of Patents and Trademarks of the United States of America to note and record the existence of the release hereby given.
