RELEASE OF SECURITY AGREEMENT

THIS RELEASE dated as of July, 23 2008 (this "Release") is made by The Chase Manhattan Bank, a bank, acting in its capacity as agent (together with any successor(s) thereto in such capacity, the "Agent") for each of the Lender Parties (as defined in the Security and Pledge Agreement) under that certain Security and Pledge Agreement, dated as of January 7, 1998 and recorded in the records of the United States Patent and Trademark Office, beginning at Reel 1720, Frame 0001 (as amended, supplemented or modified and in effect from time to time, the "Security Agreement"), among Paragon Trade Brands, Inc. (the "Grantor") and the Agent;

WITNESSETH

WHEREAS, pursuant to the Security Agreement which was recorded in the records of the United States Patent and Trademark Office, the Grantor granted to the Agent a security interest in the Collateral (as defined in the Security Agreement), including those set forth on the attached schedules, including the Trademarks referenced on Reel 1720, Frame 0001 through Frame 1720, Reel 0010, as well as all other intellectual property and collateral assets specified in that Agreement;

WHEREAS, the Agent wishes to

- (i) terminate the Security Agreement against the Collateral including those identified in the attached schedules hereto, recorded with the United States Patent and Trademark Office;
- (ii) release all of its security interest covering the Collateral including those listed in the attached schedules;
- (iii) restore all right, title and interest in and to the Collateral including those listed in the attached schedules, to Grantor; and
- (iv) to dissolve any and all liens and encumbrances respecting the Collateral including those listed in the attached schedules.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Agent hereby releases its security interest in the Collateral including those set forth on the attached schedules hereto, and discharges, quit claims and relinquishes unto Grantor, (in each case, without recourse and without any representation or warranty) any and all rights, title and interest it has in and to the Collateral, and the Security Interest granted to Agent in the Collateral, including those listed in the attached schedules.
