INTELLECTUAL PROPERTY SECURITY AGREEMENT

INTELLECTUAL PROPERTY SECURITY AGREEMENT, dated as of August 1, 2008, between CONVATEC INC., a Delaware corporation ("**Grantor**"), and J.P. MORGAN EUROPE LIMITED, as Security Agent for the Secured Parties (herein in such capacity, the "**Security Agent**").

RECITALS

- (A) Cidron Healthcare B S.à r.l. (the "**Parent**") has entered into a senior secured facilities agreement dated 27 June 2008 between, amongst others, J.P. Morgan plc, The Governor and Company of The Bank of Ireland, Dresdner Kleinwort Limited, GE Corporate Finance Bank SAS, Bayerische Hypo –und Vereinsbank AG, London Branch, HSH Nordbank AG, Copenhagen Branch, Mizuho Corporate Bank Ltd, Skandinaviska Enskilda Banken AB (publ) and Swedbank AB (publ), New York Branch, as the Senior Arrangers (the "**Senior Facilities Agreement**").
- (B) The Parent has entered into a mezzanine secured facilities agreement dated 27 June 2008 between, amongst others, J.P. Morgan plc, The Governor and Company of The Bank of Ireland, Dresdner Kleinwort Limited and Bayerische Hypo –und Vereinsbank AG, London Branch, as the Mezzanine Arrangers (the "**Mezzanine Facilities Agreement**" and, together with the Senior Facilities Agreement, the "**Facilities Agreements**").
- (C) The Parent, amongst others, has entered into an intercreditor agreement dated on or about the date of the Facilities Agreements in relation thereto (the "**Intercreditor Agreement**").
- (D) Grantor is an Obligor under and as defined in each of the Facilities Agreements and the Intercreditor Agreement.
- (E) Grantor is party to a Pledge and Security Agreement, dated as of August 1, 2008, in favor of the Security Agent (the "**Pledge and Security Agreement**"), pursuant to which Grantor is required to execute and deliver this Agreement.
- (F) In consideration of the mutual conditions and agreements set forth in the Facilities Agreements, the Pledge and Security Agreement and this Agreement, and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties hereto hereby agree as follows:

SECTION 1 **Defined Terms**

Unless otherwise defined herein, terms defined in the Pledge and Security Agreement and used herein have the meaning given to them in the Pledge and Security Agreement.

SECTION 2 **Grants of Security Interests in Intellectual Property Collateral**

- (A) As security for the prompt and complete payment and performance in full when due (whether at stated maturity, by required prepayment, declaration, acceleration, demand or otherwise, including the payment of amounts that would become due but for the operation of the automatic stay under Section 362(a) of the Bankruptcy Code) of all Senior Liabilities, Grantor hereby pledges, assigns, transfers and grants to the Security Agent, for its benefit and for the benefit of the Senior Secured Parties, a continuing security interest in and Lien on all of its right, title and interest in, to and under all Intellectual Property Collateral, whether now owned or existing or hereafter acquired or arising.

(B) As security for the prompt and complete payment and performance in full when due (whether at stated maturity, by required prepayment, declaration, acceleration, demand or otherwise, including the payment of amounts that would become due but for the operation of the automatic stay under Section 362(a) of the Bankruptcy Code) of all Mezzanine Liabilities, Grantor hereby pledges, assigns, transfers and grants to the Security Agent, for its benefit and for the benefit of the Mezzanine Finance Parties, a continuing security interest in and Lien on all of its right, title and interest in, to and under all Intellectual Property Collateral, whether now owned or existing or hereafter acquired or arising.

"Intellectual Property Collateral" means Grantor's right, title and interest in, to and under

- (a) all Copyrights to which it is a party, including those referred to on Schedule I hereto,
- (b) all Patents to which it is a party, including those referred to on Schedule II hereto and
- (c) all Trademarks to which it is a party, including those referred to on Schedule III hereto;
- (d) all goodwill of the business connected with the use of, and symbolized by, each Trademark;
- (e) all reissues, continuations or extensions of the foregoing; and
- (f) all Proceeds of the foregoing, including any claim by Grantor against third parties for past, present, future (i) infringement or dilution of any (x) Copyright or Copyright Licensed under any Copyright License, (y) Trademark or Trademark licensed under any Trademark License or (z) Patent or Patent licensed under any Patent License or (ii) injury to the goodwill associated with any Trademark or any Trademark licensed under any Trademark License.

SECTION 3 Separate and Distinct Grants of Security

Notwithstanding anything to the contrary contained in this Agreement, Grantor and the Security Agent (on behalf of the Secured Parties) acknowledge and agree that the Security Interests granted pursuant to this Agreement to the Security Agent and all other rights and benefits afforded hereunder to the Secured Parties are expressly subject to the terms and conditions of Intercreditor Agreement and, in the event of any conflict or inconsistency between the provisions of this Agreement and the Intercreditor Agreement, the terms of the Intercreditor Agreement shall prevail. The grants of security hereunder constitute two separate and distinct grants of security: (1) the Security Interest in the Collateral granted to the Senior Secured Parties securing the Senior Liabilities, and (2) the Security Interest in the Collateral granted to the Mezzanine Finance Parties securing the Mezzanine Liabilities, and each such Security Interest shall constitute a Security Interest separate and apart (and of a different class and claim) from each other Security Interest.

SECTION 4 Certain Exclusions

Notwithstanding anything herein to the contrary, in no event shall the Collateral include and Grantor shall not be deemed to have granted a Security Interest in, any of its right, title or interest in any Intellectual Property if the grant of such Security Interest shall constitute or result in the abandonment of, invalidation of or rendering unenforceable any of its right, title or interest therein.

SECTION 5 Pledge and Security Agreement

The security interests granted pursuant to this Intellectual Property Security Agreement are granted in conjunction with the security interests granted to the Security Agent pursuant to the Pledge and

Security Agreement and Grantor hereby acknowledges and affirms that the rights and remedies of the Security Agent with respect to the security interests granted to it in the Intellectual Property Collateral made and granted hereby are more fully set forth in the Pledge and Security Agreement, the terms and provisions of which are incorporated by reference herein as if fully set forth herein.

SECTION 6 Governing Law




