- 4. <u>Counterparts</u>. This Assignment may be executed in one or more counterparts, each of which shall be deemed an original, and all of which together shall constitute one and the same agreement.
- 5. <u>Assignment of Licenses</u>. The parties hereby agree that all rights and obligations which derive from any and all license agreements into which the Assignor has ever entered with respect to the Trademarks (collectively, the "License Agreements"), is also hereby assigned to the Assignee, by virtue of the present agreement.
