TRADEMARK ASSIGNMENT

This Trademark Assignment (this "Assignment") is made this 18th day of November, 2008 by NR Management LLC (formerly known as NextRing LLC), a Delaware limited liability company ("Assignor"), in favor of QuinStreet, Inc., a California corporation ("Assignee"), pursuant to the provisions of that certain Purchase Agreement, dated as of November 7, 2008 (the "Purchase Agreement"), by and among Assignee and Assignor. Capitalized terms used but not otherwise defined herein have the respective meanings given to such terms in the Purchase Agreement.

WHEREAS, Assignor is the sole owner of the entire right, title and interest in and to the trademark set forth on Schedule 1 attached hereto and the goodwill of the business symbolized thereby (the "Mark"); and

WHEREAS, in connection with the transactions contemplated by the Purchase Agreement and for the Purchase Price set forth therein, Assignor desires to assign and transfer all of its right, title and interest in and to the Mark to Assignee.

NOW, THEREFORE, in consideration of the foregoing premises and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor hereby sells, assigns, transfers and sets over to Assignee and its successors and assigns, the entire right, title and interest in and to the Mark together with: (i) all registrations thereof and rights corresponding thereto in the United States of America and throughout the world; (ii) the right to sue for and recover damages and profits from past and future infringements thereof; (iii) all of the goodwill of the business connected with the Mark; and (iv) the right to secure renewals, reissues and extensions of the Mark or registrations thereof in the United States of America and throughout the world, the same to be held and enjoyed by Assignee, its successors, assigns and other legal representatives.

Assignor further agrees, at the request of Assignee or its successor in interest, to do all lawful acts which may be required for obtaining or enforcing trademark rights in the Mark and to otherwise aid Assignee or its successor in enforcing the rights in the Mark, all at the Assignee's expense.


This Assignment shall be binding upon Assignor, its successors and/or assigns and all others acting by, through, with or under their direction, and all those in privity therewith.
