TRADEMARK ASSIGNMENT OF SECURITY

WHEREAS, Waves Licensing, LLC, a Delaware limited liability company, located at One Commerce Center, 1201 N. Company expressly acknowledges and affirms that the rights and remedies of the Guaranteed Parties with respect to the assignment and security interest granted hereby are more fully set forth in the Agreement.
