TERMINATION OF SECURITY INTEREST IN TRADEMARKS

This **TERMINATION OF SECURITY INTEREST IN TRADEMARKS**, dated as of November 13, 2008, is made by Credit Suisse, Cayman Islands Branch (formerly known as Credit Suisse First Boston) as Collateral Agent (the "Secured Party").
