## RELEASE AND REASSIGNMENT OF TRADEMARKS

THIS RELEASE AND REASSIGNMENT dated May 31, 2008 by Harris N.A., as successor by merger with Harris Trust and Savings Bank, as collateral agent for certain banks and other financial institutions;

### WITNESSETH:

WHEREAS, Harris N.A., as successor by merger with Harris Trust and Savings Bank, as collateral agent, with its mailing address at 111 West Monroe Street, Chicago, Illinois 60603 (the "*Secured Party*") and JAMI, INC., a Kansas corporation with its mailing address at 7300 West 110<sup>th</sup> Street, Suite 210, Overland Park, Kansas 66210 (the "*Debtor*") are parties to a certain Trademark Collateral Agreement dated October 10, 2000 which was recorded in the United States Patent and Trademark Office on October 19, 2000 at Reel 002169, Frame 0275, pursuant to which the Debtor granted a security interest in and collateral assignment of certain trademarks, trademark registrations and trademark applications listed on Schedule A attached hereto, trademark licenses listed on Schedule A attached hereto, and certain other property (collectively, the "*Trademarks*"); and

WHEREAS, the Debtor has requested that the Secured Party release its security interests in the Trademarks and reassign the same to the Debtor;

(i) Each trademark, trademark registration and trademark application listed on Schedule A hereto, and all of the goodwill of the business connected with the use of, and symbolized by, each such trademark, trademark registration and trademark application; and

(ii) Each trademark license listed on Schedule A hereto and all royalties and other sums due or to become due under or in respect of each such trademark license, together with the right to sue for and collect all such royalties and other sums; and

(iii) All proceeds of the foregoing, including without limitation any claim by Debtor against third parties for damages by reason of past, present or future infringement of any trademark or trademark registration listed on Schedule A hereto or of any trademark licensed under a trademark license listed on Schedule A or by reason of injury to the goodwill associated with any such trademark, trademark registration or trademark license, in each case together with the right to sue for and collect said damages.
