By this letter sent and served via e-mail and certified mail, return receipt requested, Weide & Miller, Ltd (hereafter W&M) hereby notifies Progressive Gaming International Corporation (hereafter PGIC) that it claims and does hereby establish a Lien for Attorneys Fees and Costs (hereafter Lien) as set forth and authorized by Nevada Revised Statute Title 2, Chapter 18. This letter supplements the Notice of Attorney Lien and documents sent on December 30, 2008.

The basis for this Lien is the unpaid attorney fees and costs as shown in the attached spreadsheet which listed amounts owed for each invoice by invoice number and date. The grand total of this lien is \$97,660.22. We have previously sent you these invoices which provide a detailed itemization of each charge listed by reference number. Please contact me if you want additional copies of these invoices and I will e-mails copies to you.

We establish this statutory lien against the property identified by the W&M reference numbers associated with each invoice page for which a past due balance exists and associated issued patents, patent applications, trademark applications, trademark registrations, common law trademark rights, copyrights, federal copyright applications, federal copyright registrations and any other rights and property associated with the past due amounts. To aid in identifying which PGIC matters, listed by W&M reference number, these liens attach, I have enclosed an Aged A/R Transactions Report showing each PGIC matter, listed by W&M reference number. We have also enclosed an amended Status Report cross referencing the W&M reference number to detailed file information.

We also provide notice of a common law attorney lien against the physical files and


documents in our possession.
