Bill of Sale and Assignment of Intellectual Property Rights

This Bill of Sale and Assignment of Intellectual Property Rights (the "Assignment") is entered into on December 30, 2008, by and between Safariland, LLC (f/k/a Armor Holdings Products, LLC), a Delaware limited liability company ("Safariland"), and Hiatt and Company Limited, a corporation formed under the laws of the United Kingdom ("Hiatt").

RECITALS

- A. Hiatt is a wholly owned subsidiary of Armor Products International Limited, a corporation formed under the laws of United Kingdom ("API").
- B. API is a wholly owned subsidiary of Armor Products Holdings Limited, a corporation formed under the laws of United Kingdom ("APH").
- C. APH is a wholly owned subsidiary of Safariland.

ASSIGNMENT

In exchange for Safariland granting to Hiatt a promissory note with a principal outstanding amount of GBP £362,845, Hiatt hereby contributes, assigns, transfers, conveys and delivers, free and clear of all liens, whether legal or equitable, to Safariland, and Safariland hereby accepts and assumes, all of its right, title and interest in and to the patents and patent applications, registered trademarks and applications to register trademarks (the "Intellectual Property") listed on Schedule 1 attached hereto, together with all good will, trade secrets and know-how associated with such Intellectual Property and all other intangible assets of Hiatt's business (including, without limitation, all customer relationships with an aggregate intangible value equal to GBP £77,978, all folding rigid technologies and associated trade secrets, and all rigid technologies and associated trade secrets), all rights to sue and recover for any past, present or future infringement, dilution, damage or injury (and including the right to take over and continue any and all existing suits) to any of the foregoing and collect profits or damages with respect to same, the same to be held and enjoyed hereinafter by Safariland for its own use and for the use of its successors and assigns.
