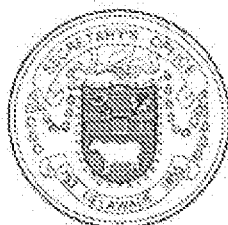

1. The name of the Corporation is Zimmer Spine Austin, Inc. (the "Corporation").

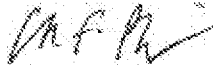
