



DAKNELL AGREEMENT AND PLAN OF MERGER

RILEY DARMELL SECRETAGREEMENT AND PLAN OF MERGER dated as of December 9, 2008, an organized OF STATE Glass Corporation, a Tennessee corporation (the "Surviving Corporation") and American Shower & Bath Corporation, a Michigan corporation (the "Merging Corporation") (with the Surviving Corporation and the Merging Corporation collectively referred to herein as the "Constituent Entities").

- A. 

This Merger is intended to constitute a statutory merger in accordance with Section 368(a)(1)(A) of the Internal Revenue Code of 1986, as amended.

All rights of creditors and all liens upon the property of the Constituent Entities shall be preserved unimpaired, and all debts, liabilities and duties of the Merging Corporation shall then be attached to the Surviving Corporation and may be enforced against it to the same extent as if the debts, liabilities and duties had been incurred or contracted by it.
