**NOTICE OF RELEASE, RELINQUISHMENT & DISCHARGE

WHEREAS La Financière du Québec ("**La Financière**") having a head office at 1200, route de l'Église, bureau 500, Sainte-Foy (Québec) G1V 5A3 and having a place of business at 393, rue St-Jacques, bureau 500, Montréal (Québec) H2Y 1N9, registered security interests with the United States Patent and Trademark Office against the intellectual property listed in **Schedule A** hereto (the "**Financière Intellectual Property**") on March 15, 2004 and February 26, 2004 (the "**Financière Security Agreements**") under Reels/Frames 015035/0808 and 2800/0242;

AND WHEREAS Investissement Québec (the "**Creditor**") having a head office at 1200, route de l'Église, bureau 500, Sainte-Foy (Québec) G1V 5A3 and a place of business at 393, rue St-Jacques, bureau 500, Montréal (Québec) H2Y 1N9, is authorized to act with respect to the rights and obligations of La Financière pursuant to Order in Council number 315-2004 of March 31, 2004 (a copy of which is attached hereto at **Schedule B**), including without limitation with respect to the Financière Intellectual Property and the Financière Security Agreements;

AND WHEREAS the Creditor also registered security interests with the United States Patent and Trademark Office against the intellectual property listed in **Schedule C** hereto (the "**IQ Intellectual Property**") on August 24, 2006 and September 1, 2006 (the "**IQ Security Agreements**") under Reels/Frames 018207/0902 and 3382/0977;

AND WHEREAS the Creditor also registered security interests with the United States Patent and Trademark Office against the intellectual property listed in **Schedule D** hereto;

AND WHEREAS the Creditor has agreed to discharge and terminate the Financière Security Agreements and IQ Security Agreements;

NOW, THEREFORE, in consideration of the foregoing premises and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged by each of the parties hereto, the parties agree as follows:

1. The Creditor hereby relinquishes, releases and terminates all of its rights, title and interests in and to the Financière Intellectual Property, IQ Intellectual Property and the intellectual property listed in Schedule D hereto.
2. The Creditor hereby directs the United States Registrar of Trade-marks and Commissioner of Patents to record the present Notice of Release, Relinquishment & Discharge of Security Interest (the "**Notice**") in such places as is necessary or advisable to give effect hereto.

3. The present Notice is executed in accordance with and is subject to, governed by and interpreted in accordance with the laws of the province of Quebec and the laws of Canada applicable therein.





UNOFFICIAL TRANSLATION OF FRENCH ORIGINAL

Government of Québec

Order in Council Number 315-2004, March 31, 2004

RESPECTING Investissement Québec's responsibilities with regard to various financial aid programs

WHEREAS paragraph 2 of section 64 of the Act respecting Investissement Québec and La Financière du Québec (R.S.Q., c. I-16.1) states that, unless otherwise indicated by context, in any text or document, regardless of its nature or form, a reference to the Société de développement industriel du Québec is a reference either to Investissement Québec or to La Financière du Québec, according to their respective responsibilities as determined by the Government;

WHEREAS, by Order in Council number 1056-98 of August 21, 1998, the Government determined the allocation of responsibilities of Société de développement industriel du Québec among Investissement Québec and Garantie-Québec;

WHEREAS section 12 of the Act respecting La Financière du Québec (S.Q. 2001, c. 69) states that a reference to Garantie-Québec is a reference to La Financière du Québec;

WHEREAS it is expedient to amend Order in Council number 1056-98 of August 21, 1998 in order to transfer to Investissement Québec the responsibilities that were assigned to La Financière du Québec by said Order in Council and, accordingly, to establish that any reference to La Financière du Québec is a reference to Investissement Québec;

WHEREAS, by Order in Council number 481-2002 of April 24, 2002, the Government established the Program to support the capitalization of biotechnology corporations;¹

WHEREAS, by Order in Council number 421-2003 of March 21, 2003, La Financière du Québec was substituted for Investissement Québec regarding the latter's responsibilities with respect to the Program to support the capitalization of biotechnology corporations and that it acquires the rights and performs the obligations thereof;²

WHEREAS, by Order in Council number 841-2000 of June 28, 2000, amended by orders in council numbers 899-2001 of July 31, 2001 and 1487-2001 of December 12, 2001, the Government adopted the Program respecting business financing,³ the administration of which is handled by La Financière du Québec;

WHEREAS, by Order in Council number 594-2000 of May 17, 2000, amended by orders in council numbers 761-2001 of June 20, 2001 and 1450-2001 of December 5, 2001, the Government adopted the Program respecting small business financing,⁴ the administration of which is handled by La Financière du Québec;

WHEREAS, by Order in Council number 374-2002 of March 27, 2002, the Government adopted the Program to support group entrepreneurship financing,⁵ the administration of which is handled by La Financière du Québec;

UNOFFICIAL TRANSLATION OF FRENCH ORIGINAL

WHEREAS, by Order in Council number 375-2002 of March 27, 2002, the Government adopted the Program to support the capitalization of social economy companies,⁶ the administration of which is handled by La Financière du Québec;

WHEREAS, pursuant to section 5 of the Act respecting assistance for the development of cooperatives and non-profit legal persons (R.S.Q. c. A-12.1), the programs of financial assistance established pursuant to said Act are administered by La Financière du Québec;

WHEREAS, pursuant to sections 27 and 59 of the Act respecting Investissement Québec and La Financière du Québec, the Government may develop financial investment assistance programs to be administered by Investissement Québec or one of its subsidiaries. The Government may also assign the administration of any other investment support program it specifies to Investissement Québec;

WHEREAS it is expedient to assign the administration of the programs adopted pursuant to orders in council numbers 481-2002 of April 24, 2002, 841-2000 of June 28, 2000 as amended, 594-2000 of May 17, 2000 as amended, 374-2002 of March 27, 2002 and 375-2002 of March 27, 2002 to Investissement Québec;

IT IS ORDERED, therefore, upon the recommendation of the Minister of Economic and Regional Development and Research:

THAT Order in Council number 1056-98 of August 21, 1998 be amended in order to transfer to Investissement Québec the responsibilities that were assigned to La Financière du Québec and to establish that, in any text or document, regardless of its nature or form, a reference to La Financière du Québec further to the application of Order in Council number 1056-98 is a reference to Investissement Québec;

THAT the programs mentioned below be amended in order to assign to Investissement Québec in lieu and stead of La Financière du Québec the administration of these programs as amended: (i) Program to support the capitalization of biotechnology corporations, established by Order in Council number 481-2002 of April 24, 2002, (ii) Program respecting business financing, established by Order in Council number 841-2000 of June 28, 2000, (iii) Program respecting small business financing, established by Order in Council number 594-2000 of May 17, 2000, (iv) Program to support group entrepreneurship financing, adopted pursuant to Order in Council number 374-2002 of March 27, 2002, and (v) Program to support the capitalization of social economy companies, adopted pursuant to Order in Council number 375-2002 of March 27, 2002;

THAT, in all the programs mentioned above and in any text or document related thereto, a reference to La Financière du Québec be a reference to Investissement Québec;

THAT the present Order in Council come into force on April 1, 2004.
