**TRADEMARK RELEASE AND REASSIGNMENT**

THIS TRADEMARK RELEASE AND REASSIGNMENT is made as of March 11, 2009, by THE CIT GROUP/BUSINESS CREDIT, INC. (as successor by merger to THE CIT GROUP/CREDIT FINANCE, INC.) ("CIT").

WITNESSETH:

WHEREAS, CIT and F & F FOODS, INC., an Illinois corporation ("Grantor"), were parties to an intellectual property security agreement dated as of July 13, 1999 (the "Assignment"), pursuant to which Grantor granted a security interest to CIT in certain trademarks (the "Trademarks") and Trademark Rights (as defined below) as security for certain obligations owing by Grantor to CIT, including the Trademarks set forth on Schedule 1 hereto; and

WHEREAS, the Assignment was recorded by the Trademark Division of the United States Patent and Trademark Office on July 30, 1999, at Reel 1940, Frame 0551; and

WHEREAS, Grantor has requested that CIT release its security interest in the Trademarks and Trademark Rights and reassign the same to Grantor.

NOW THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:

1. CIT hereby releases its security interest in all of Grantor's right, title and interest in and to the following (collectively the "Trademark Rights"):

(i) each Trademark listed on Schedule 1 annexed hereto, together with any reissues, continuations or extensions thereof, and all of the goodwill of the business connected with the use of, and symbolized by, each Trademark; and


(ii) all products and proceeds of the foregoing, including without limitation, any claim by Grantor against third parties for past, present or future (a) infringement or dilution of any Trademark, or (b) injury to the goodwill associated with any Trademark.

2. CIT hereby reassigns, grants and conveys to Grantor, without any representation, recourse or undertaking by CIT, all of CIT's right, title and interest in and to the Trademarks and the Trademark Rights.
