# TERMINATION, RELEASE AND REASSIGNMENT OF SECURITY INTERESTS IN TRADEMARKS

THIS TERMINATION, RELEASE AND REASSIGNMENT OF SECURITY 12<sup>th</sup> day of February INTERESTS IN TRADEMARKS ("Release") made as of the \_\_\_\_ day of November, 2008-by 2009 IPMorgan Chase, successor by merger to The Chase Manhattan Bank, with its mailing address at 270 Park Avenue, New York, New York 10017 ("IPMC"), as Agent for itself and each of the other entities party to that certain Security Agreement dated as of October 1, 1991, and for Canandaigua Wine Company, Inc., a corporation of the State of Delaware, with a mailing address of 370 Woodcliff Drive, Suite 300, Fairport, New York 14450 ("Canandaigua").

#### WITNESSETH

WHEREAS, JPMC and Canandaigua entered into a certain Trademark Security Agreement dated as of October 1, 1991 (the "Security Agreement"), by which Canandaigua granted to JPMC as Agent a lien on and continuing security interest in, among other things, trademarks, service marks, trademark registrations (listed on Schedule A hereto), trade names, and the goodwill of the business connected therewith and symbolized thereby, as security for, among other things, the payment and performance in full of the Secured Obligations (capitalized used herein are defined as in the Security Agreement);

WHEREAS, the Security Agreement was recorded in the United States Patent and Trademark Office (the "PTO") on November 6, 1991, at Reel 0826, Frame 0544;

WHEREAS, Canandaigua has requested that JPMC terminate and release its security interest in and lien on Canandaigua's said trademarks, as described below, and reassign the same to Canandaigua;

NOW THERFORE, in consideration of the premises and for other good and valuable consideration, the receipt of which are hereby acknowledged, it is agreed as follows:

- 1. JPMC does hereby release and terminate all liens and security interests in all the following properties of Canandaigua which were granted, bargained, sold, transferred, assigned, mortgaged and pledged to JPMC as collateral security for the Secured Obligations under and pursuant to the Security Agreement, and JPMC hereby without recourse and without representation or warranty of any kind, assigns, sells, conveys, grants, sets over, transfers and releases to Canandaigua any other and all of JPMC's right, title and interest, if any, in and to the following, purportedly owned by Canandaigua whether at the time of said grant, assignment, mortgage and pledge under and pursuant to the Security Agreement or thereafter acquired:
- A.) the United States trademarks listed on Schedule A attached hereto and made a part hereof and all other trademarks (including service marks), trademark registrations and trade names in the United States in each case (i) including all or a significant or meaningful part of, or (ii) constituting a variant or derivative of, or (iii) not readily distinguishable from, the marks listed in Schedule A, along with any and all (iv) renewals thereof, (v) income, royalties, damages and payments now and hereafter due or payable with respect thereto, including without limitation

damages, claims and payments for past or future infringements thereof, (vi) rights to sue for past, present, or future infringements thereof, and (vii) trademarks, trademark registrations and trade name applications for any thereof and any other rights corresponding thereto (collectively the "Trademarks");

- B.) the entire goodwill of Canandaigua's business connected with the use of and symbolized by the Trademarks;
- C.) licenses whereby Canandaigua has granted, or Canandaigua grants to another party, the right to exploit or use any Trademark; and
  - D.) all proceeds of and accessions to any and all of the foregoing (the "Proceeds").
- 2. The parties hereto, JPMC and Canandaigua, do hereby cancel and terminate the Security Agreement and all rights and obligations of the parties thereunder.
- 3. The parties hereto agree that, at any time and from time to time upon the written request of the other party, each party will execute and deliver such further documents and do such further acts and things as may be reasonably requested by the other party in order to effect the purposes of this Release.
- 4. The Release shall be governed by and construed in accordance with the laws of the State of New York.
