RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS TRADEMARK RELEASE (this "Release") is made as of March 31, 2009, by FULL CIRCLE PARTNERS, LP, a Delaware limited partnership ("FCP"), and FCC, LLC, a Florida limited liability company doing business as First Capital ("FCC"), and together with FCP, the "Lenders").

WITNESSETH:

WHEREAS, pursuant to that certain Grant of Security Interest in Trademarks, dated November 30, 2007 (the "Security Agreement"), QOL Medical, LLC, a Delaware limited liability company (the "Company") has granted to the Lenders a security interest in the Trademark Collateral (as defined in the Security Agreement), including the Trademarks set forth in Schedule 1 (the "Trademarks");

WHEREAS, the Company has requested that the Lenders release its lien on the Trademarks and the other Trademark Collateral.




