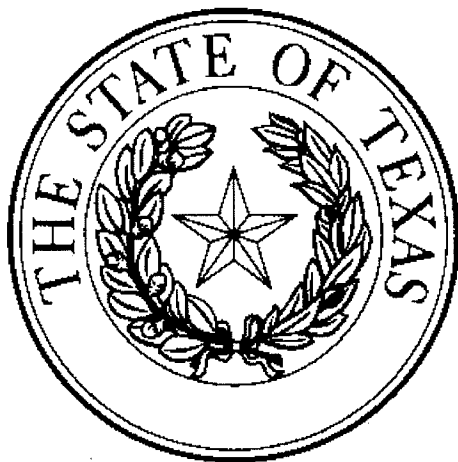

ARTICLES OF AMENDMENT

**Corporations Section**

Pursuant to the provisions of Article 1396-4.03 of the Texas Non-Profit Corporation Act, the Greater Dallas Chamber of Commerce, a Texas non-profit corporation adopts the following articles of amendment:

1. The name of the corporation is the Greater Dallas Chamber of Commerce.
2. Article I of the Articles of Incorporation is deleted in its entirety and the following substituted in lieu thereof:

ARTICLE I

NAME

The name of the corporation is DALLAS REGIONAL CHAMBER.

3. The foregoing amendment was adopted at a meeting of the members of the Executive Committee of the corporation held on December 12, 2007, at which a quorum was present and the amendment received at least two-third of the votes that members present or represented by proxy were entitled to cast.
