TRADEMARK ASSIGNMENT

WHEREAS, **CTB IP, INC.**, a corporation organized and existing under the laws of the State of **Delaware** having its principal place of business at **300 Delaware Avenue, Suite 1253, Wilmington, Delaware 19801** (hereinafter "ASSIGNOR"), has adopted, used and is using, and is the owner of the Trademark Registrations and Trademark Applications (hereinafter the "MARKS") listed on Schedule A attached hereto.
