### TRADEMARK SECURITY AGREEMENT

TRADEMARK SECURITY AGREEMENT, dated as of May 27, 2009 by EMPIRE TODAY, LLC (f/k/a EMPIRE HOME SERVICES, LLC), a Delaware limited liability company ("<u>Grantor</u>"), in favor of 333 NORTHWEST INVESTMENTS, LLC, as Agent, and the Second Lien Lenders referred to below.

#### WITNESSETH:

WHEREAS, pursuant to that certain Second Lien Loan Agreement dated as of the date hereof (including all annexes, exhibits or schedules thereto, as from time to time amended, restated, supplemented or otherwise modified, the "Second Lien Loan Agreement"; terms used but not defined herein are used as defined in the Second Lien Loan Agreement) by and among Grantor, Agent and the persons signatory thereto from time to time as Second Lien Lenders, the Second Lien Lenders have agreed to make the Second Lien Loans to Grantor;

WHEREAS, Agent and the Second Lien Lenders are willing to make the Second Lien Loan Advances as provided for in the Second Lien Loan Agreement, but only upon the condition, among others, that Grantor, as Debtor, together with certain other parties as Debtors, shall have executed and delivered to Agent, for itself and the ratable benefit of the Second Lien Lenders, that certain Security Agreement dated as of the date hereof (including all annexes, exhibits or schedules thereto, as from time to time amended, restated, supplemented or otherwise modified, the "Security Agreement");

WHEREAS, pursuant to the Security Agreement, Grantor is required to execute and deliver to Agent, for itself and the ratable benefit of the Second Lien Lenders, this Trademark Security Agreement;

NOW, THEREFORE, in consideration of the premises and mutual covenants herein contained and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Grantor hereby agrees as follows:

- 1. GRANT OF SECURITY INTEREST IN TRADEMARK COLLATERAL. As security for the payment of all Indebtedness (as defined in the Security Agreement), Grantor hereby grants to Agent, on behalf of itself and the Second Lien Lenders, a continuing security interest in all of Grantor's right, title and interest in, to and under the following, whether presently existing or hereafter created or acquired (collectively, the "<u>Trademark Collateral</u>"):
  - (a) all of its Trademarks (as hereinafter defined) and Trademark Licenses (as hereinafter defined) to which it is a party, including those referred to on <u>Schedule I</u> hereto;
    - (b) all reissues, continuations or extensions of the foregoing;
  - (c) all good will of the business connected with the use of, and symbolized by, each Trademark and each Trademark License; and
  - (d) all products and proceeds of the foregoing, including, without limitation, any claim by Grantor against third parties for past, present or future (i) infringement or dilution

of any Trademark or Trademark licensed under any Trademark License or (ii) injury to the goodwill associated with any Trademark or any Trademark licensed under any Trademark License.

As used herein the term "<u>Trademark</u>" means (a) all trademarks, trade names, corporate names, the Grantor names, business names, fictitious business names, trade styles, service marks, logos and other source of business identifiers, and all goodwill associates therewith, now existing or hereafter adopted or acquired, all registrations and recordings thereof, and all applications in connection therewith, whether in the United States Patent and Trademark Office or in any similar office or agency of the United States, any State thereof or any other country or any political subdivision thereof, or otherwise, and all common-law rights related thereto, including any of the foregoing referred to on <u>Schedule I</u>, and (b) the right to obtain all renewals thereof.

As used herein the term "<u>Trademark License</u>" means, collectively, each agreement, whether written or oral, providing for the grant by or to the Grantor of any right to use any Trademark, including any of the foregoing referred to on Schedule I.

- 2. <u>SECURITY AGREEMENT</u>. The security interests granted pursuant to this Trademark Security Agreement are granted in conjunction with the security interests granted to Agent, on behalf of itself and the Second Lien Lenders, pursuant to the Security Agreement. Grantor hereby acknowledges and affirms that the rights and remedies of Agent with respect to the security interest in the Trademark Collateral made and granted hereby are more fully set forth in the Security Agreement, the terms and provisions of which are incorporated by reference herein as if fully set forth herein.
- 3. <u>REPRESENTATION</u>. Grantor represents and warrants that, based on a diligent investigation by Grantor, the Trademarks listed on <u>Schedule I</u> constitute all of the registered Trademarks now owned by Grantor. If, before the Indebtedness shall have been satisfied in full, Grantor shall obtain rights to any new Trademark Collateral, the provisions of Section 1 shall automatically apply thereto and Grantor shall give to Agent prompt notice thereof in writing. Grantor authorizes Agent to modify this Agreement by amending <u>Schedule I</u> to include any future Trademarks.
