#### RELEASE OF TRADEMARK SECURITY

This Release may be executed in any number of counterparts, but all of such counterparts shall together constitute one and the same instrument. This Release shall be governed and construed in accordance with the laws of the Commonwealth of Massachusetts, without regard to the principles thereof relating to conflict of laws.
