**CONFIRMATORY TRADEMARK ASSIGNMENT**

NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, Assignor does hereby nunc pro tunc, effective April 1, 2009, sell, assign, set over and transfer unto Assignee, all right, title and interest in and to the Assigned Marks, and the U.S. trademark registrations therefore as set forth in Exhibit A hereto, together with the whole of the goodwill of the business symbolized by said Assigned Marks, the same to be held and enjoyed by Assignee for its own use and enjoyment, and for the use and enjoyment of its successors, assigns or other legal representatives, as fully and entirely as the same would have been held and enjoyed by Assignor if this Confirmatory Assignment and sale had not been made; together with all claims for damage by reason of past infringement of the Assigned Marks, with the right to sue for and collect the same for Assignee's own use and behalf, and for the use and on behalf of its successors, assigns or other legal representatives.
