NUNC PRO TUNC ASSIGNMENT

This *nunc pro tunc* Assignment ("Assignment"), effective as of July 2, 2008, is from Southern Indiana Furniture Company, Inc., an Indiana corporation, formerly known as Child Craft Industries, Inc. ("ASSIGNOR"), to Child Craft, LLC, an Indiana Limited Liability Company ("ASSIGNEE"):

WHEREAS, ASSIGNOR desires to assign, convey, and transfer to ASSIGNEE all of its right, title, and interest in and to the Marks and all rights in the registrations thereof, the '813 Application, the Copyrights, and (4) domain names; and

WHEREAS, ASSIGNEE is desirous of acquiring the rights in and to the Marks and all rights in the registrations thereof, the '813 Application, the Copyrights, and domain names;

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which is hereby acknowledged, ASSIGNOR hereby assigns, conveys, and transfers to ASSIGNEE all of ASSIGNOR'S right, title, and interest of whatever kind in and to the Marks and the registrations worldwide thereof identified in *Exhibit A* together with the good will of the business in which the marks are used.

ASSIGNOR also hereby assigns, conveys, and transfers to ASSIGNEE, the entire right, title and interest in and to the '813 Application and the inventions disclosed therein, and in and to any and all subsequent Letters Patents of the United States and foreign countries which may be

obtained therefor.

ASSIGNOR also hereby assigns, conveys, and transfers all right, title, and interest in and to the Copyrights, including the copyright rights therein and any applications relating thereto.

ASSIGNOR also hereby assigns, conveys, and transfers all right, title, and interest in and to the domain names identified in **Exhibit A**.

Assignor warrants that no assignment, sale, agreement or encumbrance has been or will be made or entered into which would conflict with this Nunc Pro Tunc Assignment.


