INTELLECTUAL PROPERTY SECURITY RELEASE AGREEMENT

This INTELLECTUAL PROPERTY SECURITY RELEASE AGREEMENT (the "*IP Security Release*") is made as of July 2, 2009, by Bank of America, N.A., as Collateral Agent (the "*Collateral Agent*") for each of the Secured Parties (as defined in the Credit Agreement referred to below), in favor of Solo Cup Company; Solo Cup Investment Corporation; P.R. Solo Cup, Inc.; SF Holdings Group, Inc.; Lily-Canada Holding Corporation; and Solo Cup Operating Corporation, f/k/a Sweetheart Cup Company, Inc. and as successor in interest to Solo Cup Company (Illinois) (collectively, the "*Grantors*"). All capitalized terms used herein but not otherwise defined herein shall have the meanings ascribed to those terms in the Credit Agreement and the IP Security Agreement (as defined below);

WHEREAS, Solo Cup Company, a Delaware corporation, entered into a Credit Agreement dated as of February 27, 2004 (as amended, amended and restated, supplemented or otherwise modified from time to time, the "*Credit Agreement*"), with Solo Cup Investment Corporation, a Delaware corporation, the Lenders party thereto from time to time and Bank of America, N.A., as Administrative Agent, Swing Line Lender and L/C Issuer, Harris Trust and Savings Bank, as Documentation Agent and as an L/C Issuer, and the other Agents named therein;

WHEREAS, as a condition precedent to the making of Loans by the Lender and the issuance of Letters of Credit by the L/C Issuers under the Credit Agreement and the entry into Secured Hedge Agreements by the Hedge Banks from time to time, each Grantor executed and delivered to the Collateral Agent (i) that certain Security Agreement dated February 27, 2004 made by the Grantors (as amended, amended and restated, supplemented or otherwise modified from time to time, the "*Security Agreement*") pursuant to which each Grantor granted to the Collateral Agent, for the ratable benefit of the Secured Parties, a security interest in such Grantor's right, title and interest in and to the Collateral and (ii) that certain Intellectual Property Security Agreement dated as of February 27, 2004 made by the Grantors (as amended, amended and restated, supplemented or otherwise modified from time to time, the "*IP Security Agreement*") (iii) that certain Intellectual Property Security Agreement Supplement, dated April 20, 2006 made by the Grantors (the "*IP Security Agreement Supplement*");

WHEREAS, the IP Security Agreement was recorded with the Patent Division of the United States Patent and Trademark Office on April 19, 2004 at Reel 015209 and Frame 0247; with the Trademark Division of the United States Patent and Trademark Office on April 19, 2004 at Reel 002949 and Frame 0845; and with the United States Copyright Office on April 26, 2004 in Volume 3509 and Document No. 946;

WHEREAS, the IP Security Agreement Supplement was recorded with the Patent Division of the United States Patent and Trademark Office on May 11, 2006 at Reel 017596 and Frame 0864; and with the Trademark Division of the United States Patent and Trademark Office on May 11, 2006 at Reel 003306 and Frame 0786;

WHEREAS, Solo Texas, LLC was dissolved on November 17, 2005; Newcup, LLC was dissolved on November 29, 2005; Cupcorp, Inc. was dissolved on November 30, 2005;

Emerald Lady Inc. was dissolved on December 22, 2005 and Solo Management Company was dissolved on December 29, 2006;

WHEREAS, Sweetheart Holdings Inc. was merged into Sweetheart Cup Company, Inc. on May 19, 2004; Sweetheart Cup Company, Inc. changed its name to Solo Cup Operating Corporation on September 2, 2005; and Solo Cup Company (Illinois) was merged into Solo Cup Operating Corporation on October 3, 2005; and

WHEREAS, the Collateral Agent now desires to release its security interest in and to the Grantors' right, title and interest in and to the Collateral identified in this IP Security Release.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Collateral Agent and the Grantors hereby agree as follows:

SECTION 1. Release of Security Interest. The Collateral Agent hereby terminates and releases in its entirety its security interest in all of each Grantor's right, title and interest in and to the following:

- (i) the patents and patent applications set forth in Schedule A hereto;
- (ii) the trademark and service mark registrations and applications set forth in Schedule B hereto, together with the goodwill symbolized thereby;
- (iii) the copyright registrations and applications and exclusive copyright licenses set forth in Schedule C hereto;
- (iv) all reissues, divisions, continuations, continuations-in-part, extensions, renewals and reexaminations of any of the foregoing, all rights in the foregoing provided by international treaties or conventions, all rights corresponding thereto throughout the world and all other rights of any kind whatsoever of such Grantor's accruing thereunder or pertaining thereto;
- (v) any and all claims for damages and injunctive relief for past, present and future infringement, dilution, misappropriation, violation, misuse or breach with respect to any of the foregoing, with the right, but not the obligation, to sue for and collect, or otherwise recover, such damages; and
- (vi) any and all proceeds of, collateral for, income, royalties and other payments now or hereafter due and payable with respect to, and supporting obligations relating to, any and all of the Collateral of or arising from any of the foregoing.

SECTION 2. Recordation. The Collateral Agent hereby authorizes and requests that the Register of Copyrights, the Commissioner for Patents and the Commissioner for Trademarks and any other applicable government officer record this IP Security Release.


