TRADEMARK ASSIGNMENT AGREEMENT

This TRADEMARK ASSIGNMENT AGREEMENT (the "Agreement"), dated as of July 30, 2009 (the "Effective Date") is by and between **Quiksilver, Inc.**, a Delaware corporation, having its head office at 15202 Graham Street, Huntington Beach, California ("Assignor"), and **Quiksilver Americas, Inc.**, a California corporation, having its head office at 15202 Graham Street, Huntington Beach, California ("Assignee").

WHEREAS, Assignor is the owner of the trademarks and service marks set forth on Schedule A hereto and desires to transfer all of Assignor's right, title and interest therein in the jurisdictions set forth on Schedule A (the "Territory") to Assignee;

WHEREAS, Assignee desires to acquire all of Assignor's right, title and interest in such trademarks and service marks in the Territory and is acquiring the portion of the business to which such marks pertain; and

WHEREAS, pursuant to that certain Credit Agreement, dated as of the Effective Date (as amended, amended and restated, modified, supplemented or restated and in effect from time to time), among the Assignee, the Assignor, Rhone Group L.L.C. (in its capacity as administrative agent thereunder) and the other lenders party thereto (the "Credit Agreement"), in which the Assignor has agreed to perform the assignment hereunder.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties agree as follows:

1. Assignment of Marks: Assignor hereby irrevocably assigns to Assignee, and Assignee hereby accepts the assignment of, all of Assignor's right, title and interest in, to and under the following:
 - a) the trademark and service mark applications and registrations set forth on Schedule A hereof, all trade names related thereto in the Territory, and all common law equivalents therein in the Territory, together with the goodwill of the business connected with the use thereof and symbolized thereby (the "Trademarks");
 - b) all rights of priority in the Territory associated with, and all renewals of, any of the Trademarks;
 - c) all income, royalties, accrued royalties, damages and payments due or payable as of the Effective Date or thereafter with respect to the Trademarks, including, without limitation, payments under licenses granted by Assignor with respect to use of the Trademarks (the "Licenses") and damages and payments due or payable for past or present infringements, misappropriations, dilutions or other violations of the Trademarks; and
 - d) the right to sue for past, present and future infringements, misappropriations, dilutions or other violations of any of the Trademarks,

and any money damages awarded or received by Assignor on account of such suit (or the threat of such suit),

for Assignee's own ownership, use and enjoyment, and for the ownership, use and enjoyment of Assignee's successors, assigns, or other legal representatives, as fully and entirely as the same would have been held and enjoyed by Assignor if this Agreement had not been made.

2. Licenses: The assignment of the Trademarks to Assignee hereunder shall be subject to all Licenses existing as of the Effective Date. Assignor and Assignee acknowledge and agree that, Assignor, within thirty (30) days after the Effective Date, shall (i) novate to Assignee all Licenses that Assignor has granted to its affiliates, (ii) novate or, if novation is not acceptable to the licensee, assign (to the extent that the License is assignable), all Licenses that Assignor has granted to unaffiliated third parties, and (iii) use commercially reasonable efforts to obtain the licensee's consent to novation or assignment with respect to non-assignable Licenses. Assignor hereby assigns to Assignee any payments due to Assignor with respect to the Trademarks under non-assignable Licenses.

3. Further Assurances: Assignor agrees to execute and deliver such further lawful documents and instruments, and to perform such additional lawful acts, without further consideration but at Assignee's cost and expense, as Assignee may reasonably require to fully effectuate and record the assignments made hereunder, including, without limitation, in the United States Patent and Trademark Office and the appropriate registries and offices in other relevant jurisdictions.

4. Choice of Law: Except to the extent preempted by United States Federal law or the law of any other jurisdiction in which the Trademarks are registered, this Agreement shall be governed by, and construed in accordance with, the laws of the State of California.

5. Lien: The assignment of the Trademarks to Assignee hereunder is made free and clear of all liens other than the Licenses and the liens granted pursuant to, or permitted under, the Credit Agreement.
