MEMORANDUM OF SECURITY AGREEMENT

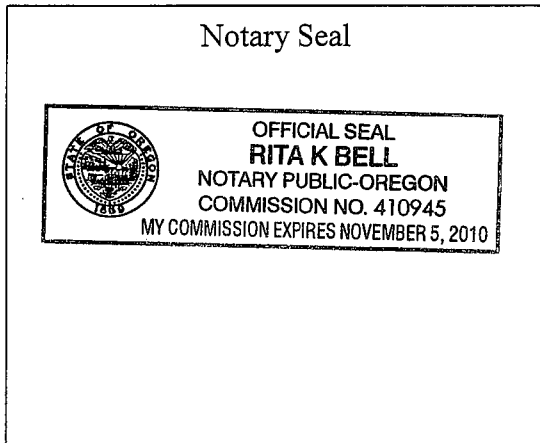


