CONFIRMATORY TRADEMARK ASSIGNMENT

This Confirmatory Trademark Assignment, effective as of September 29, 2006 (“**Effective Date**”), is between EMERSON POWER TRANSMISSION MANUFACTURING, L.P., a Missouri limited partnership (“**Assignor**”), having a principal place of business at 7120 New Buffington Road, Florence, Kentucky 41042, and EMERSON POWER TRANSMISSION MANUFACTURING, a Missouri general partnership (“**Assignee**”), having a principal place of business at 7120 New Buffington Road, Florence, Kentucky 41042.

RECITALS

- A. As of the Effective Date, the trademarks and applications and registrations therefore identified in **Appendix A** (collectively, the “**Trademarks**”) were owned by Assignor, a limited partnership, organized under the laws of the State of Missouri, composed of Emerson Power Transmission Bearings, Inc., a Delaware corporation, as the general partner and Emerson Power Transmission Drives and Components, Inc., a Delaware corporation, as the limited partner.
- B. On the Effective Date, Emerson Power Transmission Bearings, Inc. and Emerson Power Transmission Drives and Components, Inc., formed a general partnership under the laws of the State of Missouri pursuant to the Emerson Power Transmission Manufacturing Partnership Agreement dated September 29, 2006 (the “**Partnership Agreement**”).
- C. On the Effective Date, the limited partnership was cancelled per the certificate of cancellation attached as **Appendix B**.
- D. By operation of law and pursuant to the Partnership Agreement, upon cancellation of the limited partnership, all right, title and interest in and to the Trademarks was conveyed from the limited partnership (Assignor) to the general partnership (Assignee).
- E. As of the Effective Date, the business of Assignor to which the Trademarks pertain was ongoing and existing, and Assignee is the successor to the business of Assignor to which the Trademarks pertain (as required by 15 U.S.C. § 1060).
- F. The parties now desire to confirm and document passage of all right, title and interest in and to the Trademarks from Assignor to Assignee.

Therefore, in consideration of the foregoing recitals, the covenants set forth in the Partnership Agreement, one dollar (US \$1.00), and other good and valuable consideration, the receipt and sufficiency of which the parties acknowledge, the parties agree as follows:

ASSIGNMENT

Assignor hereby confirms its assignment, effective as of the Effective Date, and assigns to Assignee all right, title and interest in and to each of the Trademarks, including the listed registrations and applications for registration for each Trademark, any and all rights provided by international conventions and treaties, and the right to sue for past infringement and to keep for itself any recovery derived from any such infringement, together with the goodwill associated with such Trademarks.

By the signatures of their duly authorized representatives below, the parties ratify, endorse and confirm the assignments confirmed by this agreement.
