respect to any of the Trademarks occurring prior to the date hereof to hold the same unto the Assignee absolutely.



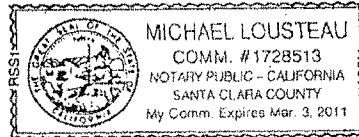
