ASSIGNMENT OF TRADEMARK

THIS ASSIGNMENT IS MADE this day of 9/22/09, 2009 and is by and between KYUNG DONG AMERICA, INC., a corporation organized and existing under the laws of the State of California, with the principle place of business at 17855 Fitch Ave., Irvine, CA 92614, (hereafter referred as "Assignor"), and KYUNG DONG NAVIEN CO., LTD., a corporation organized and existing under the laws of Republic of Korea, with the principle place of business at 437, Sekyo-dong, Pyungtaek-si, Kyungki-do, Republic of Korea, (hereafter referred as "Assignee").

WHEREAS, Assignor had adopted, used, and was using, and Assignor is the owner of the mark "NAVIEN" for gas boilers, boilers for household purposes, namely, hearths, hot water heater, water heaters, ventilators for domestic and industrial use, sold, and distributed by Assignor, in Interstate Commerce, and was the owner of the mark at all times prior to the assignment referenced herein, and Assignor is currently using the mark in the Interstate Commerce until assigned herein;

WHEREAS, the ownership of the mark is documented by U.S. Trademark registration No. 3,617,674 covering the Trademark "NAVIEN", and



NOW, THEREFORE, for good and valuable consideration paid to Assignor by Assignee, receipt whereof is hereby acknowledged, Assignor hereby assigns and transfers to Assignee, his successors, executors, administrators and assigns all of Assignor's rights in, to, and of the mark identified above, and all rights therein, including but not limited to, all federal and state trademark rights thereof and the right to sue for past infringement, throughout the entire known world, including any territories to be established by men beyond the earth. Such assignment of the rights shall be effective retroactive as of the date of first use, or the first intent-to-use application, which ever is earlier and applicable.
