

NOTICE OF GRANT OF SECURITY INTERESTS IN TRADEMARKS

THIS NOTICE OF GRANT OF SECURITY INTERESTS IN TRADEMARKS (this "Notice"), dated as of July 28, 2009, is made by and between HOLLANDER HOME FASHIONS, LLC (the "Grantor") in favor of ISRAEL DISCOUNT BANK OF NEW YORK, as Agent (the "Secured Party" and together with the Grantor, collectively, the "Parties").

WHEREAS, the Grantor is the owner of the issued trademarks and trademark applications set forth on Schedule I attached hereto (collectively, the "Trademarks");

WHEREAS, pursuant to the terms and conditions of (a) the Loan and Security Agreement dated as of the date hereof by and among Grantor, as borrower, Israel Discount Bank of New York, as agent and as a lender, PNC Bank, National Association, as documentation agent and as a lender, and the other lenders from time to time party thereto, as lenders (the "Loan Agreement"), and (b) the Trademark Collateral Assignment and Security Agreement dated as of the date hereof by and between the Grantor and the Secured Party (the "Trademark Agreement" and together with the Loan Agreement, as each now exist or may hereafter be amended, modified, supplemented, extended, renewed, restated or replaced collectively, the "Agreements"), the Grantor granted to the Secured Party a security interest in, and lien on, certain intellectual property owned by the Grantor, including the Trademarks and all proceeds of the foregoing (collectively, the "Trademark Collateral"); and

WHEREAS, pursuant to the Agreements, the Grantor agreed to execute and deliver to the Secured Party this Notice for purposes of filing the same with the United States Patent and Trademark Office (the "PTO") to confirm, evidence and record the security interest in the Trademark Collateral granted pursuant to the Agreements.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and subject to the terms and conditions of the Agreements, the Grantor hereby grants to the Secured Party a security interest in, and lien on, the Trademark Collateral; provided, however, that the grant of security interest shall not include any Trademark that would be invalidated, canceled, voided or abandoned due to the grant and/or enforcement of such security interest, including all such United States and foreign trademark applications that are based on an intent-to-use the mark in commerce, unless and until such time that the grant and/or enforcement of the security interest will not cause such trademark to be invalidated, canceled, voided or abandoned.

The Grantor hereby authorizes the PTO to file and record this Notice together with the annexed Schedule I.

The Parties hereby acknowledge and agree that the security interest in the Trademark Collateral may only be terminated in accordance with the terms of the Agreements or upon the Parties' mutual consent.

This Notice may be executed in any number of counterparts, each of which when so executed shall be deemed to be an original and all of which when taken together shall constitute one and the same agreement.

This Notice shall be governed by, and construed in accordance with, the laws of the State of New York.

In the event of any conflict between this Notice and the Agreements, the provisions of the Agreements shall control.
